**Chapter 286.**

CHAP. 286

Resolve for Laying the County Taxes for the Year Nineteen Hundred Sixteen.

Resolved, That the sum annexed to the counties in the following schedule hereby is granted as a tax on each county respectively to be appropriated, assessed, collected and applied to the purpose of paying the debts and necessary expenses of the same and for other purposes of law, for the year one thousand nine hundred sixteen:

County taxes for nineteen hundred sixteen, as provided herein.

Androscoggin, sixty thousand dollars; Aroostook, fifty-two thousand, one hundred dollars; Cumberland, one hundred eighty-three thousand, nine hundred thirty dollars; Franklin, eighteen thousand dollars; Hancock, twenty-five thousand, eight hundred dollars; Kennebec, sixty-one thousand, twenty-five dollars; Knox, twenty-two thousand dollars; Lincoln, thirteen thousand, four hundred dollars; Oxford, twenty-five thousand dollars; Penobscot, seventy thousand dollars; Piscataquis, seventeen thousand dollars; Sagadahoc, twenty-three thousand, nine hundred dollars; Somerset, thirty-eight thousand, eight hundred dollars; Waldo, twenty thousand dollars; Washington, fifty thousand dollars; York, forty-five thousand dollars.

**Chapter 287.**

Resolve in Favor of Relief of the Heirs of Revolutionary Soldiers.

Resolved, That the Land Agent be, and hereby is, authorized to convey to the lawful holder of certificate number four hundred seventy-eight, two hundred acres of land from any vacant lands heretofore set apart to satisfy the claims of those holding certificates granted by authority of Resolves, approved March seventeenth, eighteen hundred thirty-five, and March twentieth, eighteen hundred thirty-eight, together with existing claims for trespass heretofore committed on said land.
