Chapter 293.

CHAP. 293

Resolve Appropriating Money for the Care and Maintenance of Fort William Henry in the Town of Bristol.

Resolved, That there be, and hereby is, appropriated for the care and maintenance of the memorial tower erected by the State at Fort William Henry, and for the preservation and improvement of the property of the State at said fort, the sum of six hundred dollars for the year nineteen hundred fifteen, and the sum of three hundred dollars for the year nineteen hundred sixteen; said sums to be expended under the direction of the Commissioners of the State in charge of said fort.

Fort William Henry, in favor of.

Chapter 294.

Resolve Appropriating Money to Reimburse the City of Biddeford for Money Expended for the Support of a Certain State Pauper.

Resolved, That the sum of nine hundred thirty-six dollars be, and hereby is, appropriated to be paid by the Treasurer of the State to the city of Biddeford, out of moneys of the State not otherwise appropriated, for money expended by the said city of Biddeford, for the care and support of Cyrille Nolette, a state pauper; provided, however, that said sum shall be paid only on vouchers produced by said city of Biddeford and approved by the Governor and Council.

Biddeford reimbursed for money expended on pauper account.

Chapter 295.

Resolve Reimbursing the City of Biddeford for Money Expended for the Support of Certain State Paupers.

Resolved, That the sum of seven hundred forty-two dollars be, and hereby is, appropriated, to be paid by the Treasurer of the State to the city of Biddeford, out of moneys of the State, not otherwise appropriated to reimburse said city of Biddeford for money expended for the care and support of William Landry of Biddeford, deceased, and his wife and family, during his lifetime, and for the support of Leocadie Landry, widow of the said William Landry, and the children of the said Wil-

Biddeford reimbursed for money expended on pauper account.

CHAP. 296 liam Landry, since the decease of the said William Landry, as state paupers; and said sum shall be paid only on vouchers produced by said city of Biddeford, and approved by the Governor and Council.

Chapter 296.

Resolve Appropriating Money for the Installation of Steel Filing Cases in the Office of the State Treasurer.

Steel filing cases in Treasurer's office, in favor of.

Resolved, That the sum of fifteen hundred dollars be, and hereby is, appropriated for the purpose of installing steel filing cases in the office of the State Treasurer; said appropriation to be expended during the year nineteen hundred fifteen, and should any part of said appropriation remain unexpended at the end of said time, it shall not lapse but may be expended in the succeeding year.

Chapter 297.

Resolve Authorizing the State Highway Commission to Undertake the Defense of a Certain Suit at Law against the Town of Falmouth.

Falmouth, State Highway Commission authorized to defend law suit against the town of.

Whereas, under the direction of the State Highway Commission concrete bridges have been and are being erected in this State, and in connection with the erection of said bridges, the question of the infringement of certain patents has been raised, and,

Whereas, a suit involving this question has been brought against the town of Falmouth in which suit matters of importance to many towns in the State are in issue; be it

Resolved, That the State Highway Commission is hereby authorized to undertake the defence of said suit on behalf of said town of Falmouth, to employ counsel and do any and all other things necessary in connection with said suit with the same authority as though the suit were brought against said commission and the sum of two thousand dollars is hereby appropriated to carry out the purposes of this Resolve.
