PUBLIC BONDS-CENTENNIAL WEEK-FOXES

CHAP. 247

Chapter 247.

An Act to Amend Paragraph II of Section Six of Chapter Ten of the Revised Statutes, Relating to Additional Exemption from Taxation of Sewerage District Bonds.

Be it enacted by the People of the State of Maine, as follows:

R. S., c. 10, § 6, ¶ II; 1919, c. 221; relating to exemption from taxation of certain public bonds. Paragraph II of section six of chapter ten of the revised statutes is hereby amended by inserting after the word "water" and before the word "district" in the third line thereof the words 'or sewerage,' so that said paragraph of said section, as amended, shall read as follows:

'II. Sewerage district bonds included in exemptions. All bonds issued after the first day of February, nineteen hundred and nine, by the State of Maine, or any county, municipality, village corporation or water or sewerage district therein.'

Chapter 248.

An Act to Amend Chapter Fifteen of the Public Laws of Nineteen Hundred and Seventeen Relating to Celebrating Centennial Week.

Be it enacted by the People of the State of Maine, as follows:

1917, c. 15; relating to observance of Centennial Week, amended. Chapter fifteen of the public laws of nineteen hundred and seventeen relating to celebrating Centennial Week is hereby amended so that as amended said chapter shall read as follows:

'Towns may designate any week of summer of 1920 and may appropriate money for observance. Towns and cities may designate and set apart as Centennial Week, any week of the summer of nineteen hundred and twenty, and may raise and appropriate money for the due observance thereof.'

Chapter 249.

An Act to Amend Section Fifty-one of Chapter Thirty-three of the Revised Statutes, as Amended by Chapter Two Hundred and Nineteen of the Public Laws of Nineteen Hundred and Seventeen and by Chapter One Hundred and Ninety-six of the Public Laws of Nineteen Hundred and Nineteen, Relating to the Trapping of Foxes in Lincoln County.

Be it enacted by the People of the State of Maine, as follows:

R. S., c. 33, § 51; 1917, c. 219; 1919, c. 196; relating to the use of certain devices in the trapping of fur-bearing animals and prohibiting the trapping of foxes in Lincoln county, amended. Provision prohibiting trapping of

foxes in Lincoln county repealed. So much of section fifty-one of chapter thirty-three of the revised statutes, as amended by chapter two hundred nineteen of the public laws of nineteen seventeen and by chapter one hundred ninety-six of the public laws of nineteen nineteen, as prohibits the trapping of foxes in Lincoln county is hereby repealed.

Approved November 7, 1919,

Chapted 250.

Be it enacted by the People of the State of Maine, as follows:

1917, c. 272; 1919, c. 123; relating to the control of the glare of headlights on motor vehicles, amended. Chapter two hundred and seventytwo of the public laws of nineteen hundred and seventeen, as amended by chapter one hundred and twenty-three of the public laws of nineteen hundred and nineteen is hereby further amended by striking out the words "and prescribe penalties for violation thereof" in the fourth and fifth lines of section three; also by adding the following sentence to said section: 'The certificate of the clerk of the public utilities commission shall be received as prima facie evidence in any court of law to prove that said rules and regulations have been prepared, approved and published as herein provided.' The said section, as amended, shall read as follows:

'Sec. 3. Provision authorizing public utilities commission to prescribe penalties repealed. Certificate of clerk of public utilities commission as to promulgation of rules and regulations to be accepted as prima facie evidence to prove publication. The public utilities commission shall prepare rules and regulations from time to time governing the use and operation of headlights on electric cars and lights on motor vehicles used on public highways, and may from time to time alter, rescind or add to any rules and regulations previously made by it. The rules and regulations of the commission and any changes therein shall take effect when approved by the governor and council and published at least once in each daily newspaper in the state. The certificate of the clerk of the public utilities commission shall be received as prima facie evidence in any court of law to prove that said rules and regulations have been prepared, approved and published as herein provided.'
