to day by a constable of the town, without detriment to any action then returnable or pending, until he can attend, when said actions may be entered or disposed of with the same effect as if it were the first day of the term; and it may be so adjourned without day when necessary, in which event pending actions shall be considered as continued, and actions then returnable may be returned and entered at the next term, with the same effect as if originally made returnable at said term.'

### Chapter 41.

An Act to Amend Chapter Three Hundred and Seventy-two of the Private and Special Laws of Nineteen Hundred and Five, Entitled "An Act for the Protection of Clams in Parts of the County of Sagadahoc."

Be it enacted by the People of the State of Maine, as follows:

P. & S. L., 1905, c. 372; relating to the taking of clams at Small Point harbor or from Sprague's or Morse's rivers in Sagadahoc county, supplemented. Chapter three hundred and seventy-two of the private and special laws of nineteen hundred and five is hereby amended by adding the following section:

'Sec. 2. Penalty provided. Whoever shall violate the provisions of section one of this act, shall for each offense, be fined not more than ten dollars, or imprisoned not more than thirty days.'

#### Chapter 42.

An Act to Legalize and Confirm the Incorporation and Doings of the Woman's Christian Temperance Union.

Be it enacted by the People of the State of Maine, as follows:

Incorporation of Woman's Christian Temperance Union made valid. The incorporation of the Woman's Christian Temperance Union is hereby made and declared to be legal and valid.

### Chapter 43.

An Act to Extend the Charter of the Investment Insurance & Guaranty Company. Be it enacted by the People of the State of Maine, as follows:

which was granted by chapter one hundred and sixty-nine of the private and special laws of nineteen hundred and seventeen, is hereby revived, renewed and extended for two years from the date when this act shall take effect.

### Chapter 44.

An Act to Extend the Charter of the Farmington-Oakland Interurban Railway. Be it enacted by the People of the State of Maine, as follows:

Sec. 1. Charter of Farmington-Oakland Interurban Railway extended. The charter of the Farmington-Oakland Interurban Railway, which was granted by chapter one hundred and eighty of the private and special laws of nineteen hundred and thirteen, is hereby revived, renewed and extended for two years from the date when this act shall take effect.

Sec. 2. Existing statutes continued in force. Nothing herein contained is intended to repeal or shall be construed as repealing the whole or any part of any existing statute. And all the rights and duties herein mentioned shall be exercised and performed in accordance with all the applicable provisions of chapter fifty-five of the revised statutes.

#### Chapter 45.

An Act to Amend Chapter Four Hundred and Twenty-four of the Private and Special Laws of Nineteen Hundred and Seven, as Amended by Chapter Forty-eight of the Private and Special Laws of Nineteen Hundred and Seventeen, Changing the Time of the Annual Meeting of Kittery Water District.

Be it enacted by the People of the State of Maine, as follows:

P. & S. L., 1907, c. 424, § 5; 1917, c. 48; relating to the meetings of the Kittery Water District, amended. Chapter four hundred and twenty-four of the private and special laws of nineteen hundred and seven, as amended by chapter forty-eight of the private and special laws of nineteen hundred and seventeen, is further amended by striking out "July" in the eleventh line and substituting therefor the word 'January,' so that said section, as amended, will read as follows:

'Sec. 5. Date of annual meeting changed from July to January. All the affairs of said water district shall be managed by a board of trustees composed of three members, to be chosen by ballot by the legal voters within said water district, the first election to be at the meeting of the legal voters of the said corporation to be called to accept this act, one to serve until the annual meeting to be held in nineteen hundred and eight,
