Chapter 10.

Resolve, Reimbursing Jacob Astle for Fine and Costs Paid in Case Prosecuted for Violation of the Trapping Laws.

Jacob Astle, reimbursement. Resolved: That the sum of twenty dollars and twenty-four cents be paid to Jacob Astle of Augusta.

Approved February 27, 1919.

Chapter 11.

Resolve, in Favor of Harry S. Coombs, for Furnishing Plans and Specifications for Four Model School Buildings for State Board of Education as Per Contract with the Honorable Payson Smith.

Harry S. Coombs, plans and specifications for school buildings. Resolved: That there be, and hereby is, appropriated the sum of two hundred dollars to be paid to Harry S. Coombs of Lewiston, Maine, for preparing and furnishing plans and specifications for four model school buildings for the state board of education, as per contract with the Honorable Payson Smith, which said plans were furnished during the years nineteen hundred and fourteen, nineteen hundred and fifteen, nineteen hundred and sixteen and nineteen hundred and seventeen.

Approved February 27, 1919.

Chapter 12.

Resolve, in Favor of Perley J. Guptill of Machias for Destruction of Cattle by Bears.

Perley J. Guptill, cattle killed by bears. Resolved: That there be, and hereby is, appropriated the sum of eighty-five dollars to be paid to Perley J. Guptill of Machias, county of Washington, compensation for the destruction of cattle by bears in township number thirty, Washington county.

Chapter 13.

Resolve, in Favor of the Town of Litchfield, Reimbursing Said Town for Money Paid to Litchfield Academy.

Town of Litchfield, reimbursement. Resolved: That there be, and hereby is, appropriated the sum of one hundred and thirty-three dollars and

thirty-four cents to be paid to the town of Litchfield to reimburse said town for two-thirds of two hundred dollars paid by said town to Litchfield Academy in the year nineteen hundred and seventeen, which sum of one hundred and thirty-three dollars and thirty-four cents is justly due said town from the state under the provisions of law relating thereto.

Approved February 27, 1919.

Chapter 14.

Resolve, in Favor of the Town of Union for the Payment of Additional State School Funds for the Year Nineteen Hundred and Eighteen.

Town of Union, school funds. Resolved: That there be, and hereby is, appropriated out of state school funds for the year nineteen hundred and nineteen, in favor of the town of Union, the sum of two hundred and ninety-five dollars and eighty-four cents, such amount being due said town out of state school funds for the year nineteen hundred and eighteen and not received because of an error in the census returns of said town for that year.

Chapter 15.

Resolve, in Favor of J. Wilbur Day, Compensating him for Loss of Cattle by Bears.

J. Wilbur Day, cattle killed by bears. Resolved: That there be, and hereby is, appropriated the sum of one hundred and ninety-five dollars to be paid J. Wilbur Day of Wesley, in the county of Washington, as compensation for the destruction of cattle by bears in township number thirty-one, Washington county.

Approved February 27, 1919.

Chapter 16.

Resolve, in Favor of Lydia M. Chadwick of Saco for Teacher's Pension.

Lydia M. Chadwick, teacher's pension. Resolved: That there be allowed and paid, out of the appropriation for teachers' pensions, to Lydia M. Chadwick of Saco, in the county of York, the sum of two hundred and fifty dollars per annum, during the lifetime of the said Chadwick, the sum to be paid in quarterly installments.

Approved February 27, 1919.
