## CHAP. 17

**Chapter 17.**

Resolve, Authorizing the State Land Agent to Sell Certain Lots in the Town of St. Agatha in the County of Aroostook.

**Town of St. Agatha, authorizing sale of certain lots in. Resolved:** That the land agent of the State of Maine be, and hereby is, authorized to sell for cash lots numbered ninety-four, ninety-five, ninety-six, ninety-seven, ninety-eight, ninety-nine, one hundred, one hundred and one, one hundred and two, one hundred and three, one hundred and four, one hundred and five, one hundred and six, one hundred and seven, one hundred and eight, one hundred and ten, in township numbered eighteen, range five, west of the east line of the state, if he deem it advisable, for such price per acre, and on such terms of payment as he may deem advantageous.

**Chapter 18.**

Resolve, Authorizing the State Land Agent to Sell Certain Public Lots in St. Francis Plantation in Aroostook County.

**St. Francis plantation, authorizing sale of certain lots in. Resolved:** That the land agent is hereby authorized to sell and convey to actual settlers thereon, certain lands in St. Francis plantation, in Aroostook county, constituting part of the school lots of said plantation, if he deem advisable, for such price per acre and on such terms of payment as he may deem advantageous; provided, that in making sales of said lands, the equitable rights of persons claiming under said settlers shall be considered and preserved; and provided, also, that the proceeds of any sales made shall be added to the school funds of said plantation; and it is further provided, that not over one hundred acres will be conveyed to one settler.

**Chapter 19.**

Resolve, Making an Appropriation for Co-operative Agricultural Work between the College of Agriculture of the University of Maine and the United States Department of Agriculture.

**University of Maine, co-operative agricultural work. Resolved:** That there be, and hereby is, appropriated to be paid to the University of Maine for co-operative agricultural work between its college of agriculture and the United States Department of Agriculture, as such work is defined in an act of the Congress of the United States, approved May eighth, nineteen hundred and fourteen, entitled "An act to provide for co-operative agricultural work between the agricultural colleges in the several states receiving the benefits of an act of congress, approved July second, eighteen
