JOHN P. HANEY-FISH AND GAME DEPT.

CHAP. 33

and nineteen, and the sum of five thousand dollars for the year nineteen hundred and twenty, for the purpose of public instruction in forestry. Said funds to be expended under the direction of the forest commissioner, as, provided for in revised statutes, nineteen hundred and sixteen, chapter eight, section fifty-six, and as further defined and specified herewith.

Chapter 33.

Resolve, in Favor of John P. Haney of Bangor, Penobscot County, State of Maine, for Teacher's Pension.

John P. Haney, teacher's pension. Resolved: That there be allowed and paid out of the appropriation for teacher's pensions to John P. Haney of Bangor, Penobscot county, State of Maine, the sum of one hundred and twenty-five dollars per year, in addition to the sum regularly received by said John P. Haney from said appropriation; said sum to be paid in quarterly installments during the lifetime of said John P. Haney.

Chapter 34.

Resolve, Appropriating Money for the Purpose of Operating the Fish Hatcheries and Feeding Stations for Fish, for the Protection of Fish, Game and Birds, and for Printing the Report of the Commissioner of Inland Fisheries and Game, and other Expenses Incident to the Administration of the Department of Inland Fisheries and Game.

Inland fisheries and game. Resolved: That the sum of one hundred and twenty-five thousand dollars be, and hereby is, appropriated for the year nineteen hundred and nineteen, and also one hundred and twenty-five thousand dollars for the year nineteen hundred and twenty, to be expended by the commissioner of inland fisheries and game, for the purpose of operating the fish hatcheries and feeding stations for fish in the state, for the protection of fish, game and birds, for printing the report of the commissioner of inland fisheries and game, for maintenance of the state museum, payment of bounties on bob cats killed in this state and other expenses incident to the administration of the department of inland fisheries and game, and that any of this appropriation unexpended at the end of either year shall be available for the following year.

Provided, also, that the commissioner of inland fisheries and game may purchase or lease real estate in the name of the state for the purpose of maintaining fish hatcheries and feeding stations and erecting the same for fish culture, and may also assist in maintaining fish hatcheries for fish culture owned and under the management of fish and game associations; 554 FORESTRY-WHITE PINE BLISTER RUST-WALDO CO.

provided, also, that the commissioner shall make a detailed statement in his report of all expenditures of money expended under this resolve.

Chapter 35.

Resolve, Appropriating Money for Further Maintenance of the State Forest Nursery.

State forest nursery. Resolved: That the sum of one thousand dollars be, and hereby is, appropriated for the year nineteen hundred and nineteen, and the sum of one thousand dollars for the year nineteen hundred and twenty, to be expended by the forest commissioner for the maintenance of the state forest nursery, or for establishing auxiliary nurseries; and for encouraging in any practical way the reforesting of waste or cut over lands in Maine.

Chapter 36.

Resolve, Appropriating Money for Continuance of White Pine Blister Rust Control.

White pine blister rust, control of. Resolved: That the sum of five thousand dollars be, and hereby is, appropriated for the year nineteen hundred and nineteen, and the sum of five thousand dollars for the year nineteen hundred and twenty, for the purpose of controlling and eradicating the white pine blister rust in the State of Maine, as authorized by senate bill number one hundred and seventy-one as passed by the seventyeighth legislature, nineteen hundred and seventeen, entitled "An Act Providing for the Control of the White Pine Blister Rust and Other Fungous and Insect Pests."

Chapter 37.

Resolve, Providing for the Completion of the Book of Plans of Waldo County and Appropriating Money therefor.

Waldo county book of plans. Resolved: That the state land agent be, and hereby is, instructed to cause the book of plans of Waldo county to be completed by adding to the plans already in said book such plans in the Massachusetts archives as have not already been copied, and by having all copies certified by the secretary of state for Massachusetts, after which said book shall be forwarded to the register of deeds for said county of Waldo, and the sum of two hundred and fifty dollars, or such part of that sum as may be necessary, hereby is appropriated to pay the expense of such completion.
