## Chapter 45.

Resolve, in Favor of Harry S. Coombs for Preparing Sketches and Estimates and Attendance before Legislative Hearings, Making Changes in said Sketches and Other Expenses for the Board of Trustees for the Maine State School for Girls.

**Harry S. Coombs, plans, etc., for State School for Girls. Resolved:** That there be, and hereby is, appropriated the sum of four hundred and fifty-four dollars and sixty-three cents to be paid to Harry S. Coombs, architect, of Lewiston, Maine, for labor, materials and time in preparing sketches and estimates for central school building for the board of trustees for Maine School for Girls, and attendance upon legislative hearings at their request and changing said sketches and estimates and other expenses accruing during the years nineteen hundred and twelve, nineteen hundred and thirteen, nineteen hundred and fourteen, nineteen hundred and fifteen, nineteen hundred and sixteen and nineteen hundred and seventeen.

## Chapter 46.

Resolve, in Favor of the Inhabitants of Scarborough, Reimbursing them for Expenses Incurred in Defense of Suits for Damages Alleged to have been Received upon the State Highway in Scarborough.

**Scarboro, inhabitants, reimbursement for legal expenses incurred in damage suit. Resolved:** That the sum of thirteen hundred and twenty-nine dollars and six cents be, and hereby is, appropriated to be paid to the inhabitants of the town of Scarborough, to reimburse them for legal expenses incurred and paid by them in the defense of suits affecting the liability of the state and said town, which said suits were brought against the said inhabitants for alleged injuries and damages received by various parties in an accident which occurred upon a part of the state road between Portland and Saco near the Nonsuch river in Scarborough.

## Chapter 47.

Resolve, in Favor of Ellie L. Stafford for Teacher's Pension.

**Ellie L. Stafford of Guilford, teacher's pension. Resolved:** That there be, and hereby is, appropriated the sum of one hundred and twenty-five dollars for the year nineteen hundred and nineteen and one hundred and twenty-five dollars for the year nineteen hundred and twenty as teacher's pension for Ellie L. Stafford of Guilford, the same to be paid in regular monthly installments.
