Chapter 55.

Resolve, in Favor of Rachel Stanley of Paris for Annual State Pension.

Rachel Stanley of Paris, state pension. Resolved: That there be, and hereby is, granted to Rachel Stanley of Paris an annual pension of three hundred dollars to be paid to the said Rachel Stanley in quarterly installments of seventy-five dollars each three months to the day of her death, by the governor and council, from any money in the state treasury not otherwise appropriated.

Chapter 56.

Resolve, for Extra Pay to the Maine Volunteers in the War with Spain.

Volunteers, Spanish war, extra pay. Resolved: That the sums of sixty-six dollars for the year nineteen hundred and nineteen and sixty-six dollars for the year nineteen hundred and twenty, be and hereby are, appropriated for extra pay for the Maine volunteers in war with Spain.

Approved March 19, 1919.

Chapter 57.

Resolve, in Favor of Morrison Libby of Oakland.

Morrison Libby, Oakland, expenses contested election, 1914. Resolved: That the sum of four hundred and fifty dollars be, and hereby is, appropriated for, and that said sum be paid to Morrison Libby of Oakland, Maine, to reimburse him for counsel fees paid by him for legal services in defending his title to office as county commissioner for Kennebec county after the nineteen hundred and fourteen election, said litigation arising from an error on the part of officials in printing and distributing the ballots for said election without any fault on his part or that of the voters at said election.

Chapter 58.

Resolve, in Favor of the Penobscot Tribe of Indians for the General Care, Maintenance, Relief and Education thereof.

Emergency preamble. Whereas, the State of Maine holds in trust for the Penobscot Tribe of Indians a certain large sum of money to wit; eighty-eight thousand ninety-two dollars and fifty cents, and,

Whereas, all the funds appropriated by the seventy-eighth legislature for the care, maintenance and relief of said tribe have been expended for

the purposes and in the manner prescribed by law, and because of the lack of available funds said tribe may fall into distress and be deprived of proper food, shelter and clothing, and,

Whereas, by reason of the foregoing facts the appropriation called for by this resolve is immediately necessary for the preservation of the public peace, health and safety and in the opinion of this legislature constitutes an emergency as contemplated by the constitution, be it therefore

Resolved: That there be paid from the state treasury to be expended under the direction of the governor and council by the agent of the Penobscot Tribe of Indians, for the benefit of said tribe for the years nineteen hundred and nineteen and nineteen hundred and twenty as follows:

Emergency. In view of the emergency cited in the preamble this resolve shall take effect when approved.

Chapter 59.

Resolve, Providing for a State Pension for Mrs. Alfred Polk of Lewiston.

Mrs. Alfred Polk, Lewiston, state pension. Resolved: That there be paid to Mrs. Alfred Polk of Lewiston, in the county of Androscoggin and State of Maine, the sum of eight dollars per month, payable quarterly from the fund appropriated for military pensions, beginning January first, nineteen hundred and nineteen and continuing during the pleasure of the legislature.

Chapter 60.

Resolve, in Favor of Benjamin H. Varney, Secretary of the Committee on Education.

Benjamin H. Varney, legislative committee on education, expenses. Resolved: That there be, and hereby is, appropriated to be paid to Benjamin H. Varney, secretary of the committee on education, the sum of two hundred dollars and eight cents for expenses of said committee incurred in visiting the University of Maine and state normal schools.
