As Passed by the Seventy-Ninth Legislature

1919

Chapter 69.

Resolve, Providing for the Compilation, Printing and Distribution of an Index to the Private and Special Laws and to the Resolves of the State of Maine.

State librarian authorized to compile and publish index of private acts and resolves from 1820 to present date. Resolved: That the state librarian be, and hereby is, authorized and empowered to make an index to the private and special laws of the State of Maine and to the resolves of the State of Maine, from the incorporation of the state to the year nineteen hundred and nineteen, inclusive, to employ such assistance in the making of said index as he may deem necessary, and to make a contract for the printing and publishing of not less than one thousand copies of such index.

Manner of distribution. Resolved: That the copies of the index printed under this resolve shall be deposited in the office of the state librarian, who shall distribute the same as follows: one copy to the governor and to each member of the executive council, one copy to each former governor of the state, one copy to each of the justices of the supreme judicial and superior courts and to the reporter of decisions, one copy to each former justice of the supreme judicial court, one copy to the judge of the circuit court of appeals of the United States residing in the district of Maine, one copy to the judge of the district court of the United States for the district of Maine, one copy to the secretary of state, one copy to the attorney general, one copy to each county attorney, one copy to each judge of probate, one copy to each college and theological institution, two copies to the University of Maine Law School, one copy to the Maine Historical Society, one copy to each county law library, one copy to each senator and representative of the state in congress, one copy to the library of each state or territory of the United States, two copies to the library of congress, ten copies to the librarian of the Maine state library for the use of the library; the remainder of said copies to be sold at a price to be fixed by the state librarian and the proceeds thereof to be added to the maintenance appropriation of the Maine state library. The several persons in this state furnished with the index as aforesaid shall be responsible for the same and shall deliver it to their successors in office, to be continually kept for the use of the office, and the copies so furnished for the use of such offices shall be marked as provided by section twenty-seven of chapter three of the revised statutes, and shall have a registered number conforming to the list to be kept by the librarian of the Maine state library.
