Chapter 137.

Resolve, Continuing Unexpended Balance of Appropriation Provided by Chapter Three Hundred and Ten of the Resolves of Nineteen Hundred and Fifteen, Entitled "Resolve Appropriating Money to Aid in the Construction of Substructure of a Highway Bridge across the St. John River between the Town of Madawaska, Maine, and the City of Edmundston, New Brunswick."

Unexpended balance for Madawaska-Edmundston bridge continued.

Whereas, the legislature of nineteen hundred and fifteen, by chapter three hundred and ten of the resolves of that year, appropriated the sum of five thousand dollars, to be expended under certain conditions to aid in the construction of the substructure of a highway bridge across the St. John river between the town of Madawaska, Maine, and the city of Edmundston, New Brunswick, and

Whereas, the legislature of nineteen hundred and seventeen, by chapter eighty-five of the resolves of nineteen hundred and seventeen, provided that said money should remain in the state treasury during the years nineteen hundred and seventeen and nineteen hundred and eighteen to be used for the purpose for which it was originally appropriated during the said years nineteen hundred and seventeen and nineteen hundred and eighteen, and

Whereas, all of said money was not expended but part thereof remains in the state treasury having been transferred and credited to the state contingent fund on January first, nineteen hundred and nineteen as provided by law, therefore be it

Resolved: That provided the conditions of said chapter three hundred and ten of the resolves of nineteen hundred and fifteen are complied with during the years nineteen hundred and nineteen and nineteen hundred and twenty, such part of said money so unexpended shall remain in the state treasury during those years to be used for the purpose for which it was originally appropriated and shall be available for such use until June thirtieth, nineteen hundred and twenty-one, for the payment of bills contracted for the same during the years nineteen hundred and nineteen and nineteen hundred and twenty to be expended as directed under the said original resolve.

Chapter 138.

Resolve, Authorizing the State Librarian to Purchase for the State One Hundred Copies of the History of the Town of Norway after Same are Printed.

History of Town of Norway, authorizing purchase 100 copies of by state.

Resolved: That the state librarian be, and hereby is, authorized to purchase for the State of Maine, when printed, one hundred copies at five

dollars per copy, a history of the town of Norway, Maine, by C. F. Whitman, and published by the Lewiston Journal Company; provided, that said history shall contain all the necessary records of the inhabitants of said town who served in the late war between the United States and the Central Powers; and that the sum of five hundred dollars be, and hereby is, appropriated for this purpose.

Chapter 139.

Resolve, for the Maintenance and Improvement of the State Park in Augusta.

State park, Augusta, maintenance and improvement. Resolved: That there be, and hereby is, appropriated for the state park commission the sum of three thousand dollars for the year nineteen hundred and nineteen and two thousand dollars for the year nineteen hundred and twenty for the maintenance and improvement of the state park in Augusta; said money to be appropriated from moneys not otherwise appropriated and the expenditure thereof shall be under the direction of the governor and council.

Chapter 140.

Resolve, to Appropriate Money for the Purchase of History of York.

History town of York, authorizing purchase of 125 copies of by state. Resolved: That one hundred and twenty-five copies of the "History of York, the First English City on this Continent," by Edward C. Moody, be purchased by the state at a cost of \$2.00 per copy, the same to be distributed in high schools or elsewhere at the discretion of the state librarian, or library commission.

Chapter 141.

Resolve, Authorizing and Instructing the Governor and Council to Make such Alterations and Improvements of the Residence of the late James G. Blaine, Recently Given to the State by Mrs. Harriet Blaine Beale, as May be Necessary, and to Furnish it Suitably, to Serve the Purpose of an Executive Mansion, and to Acquire by Purchase such Contiguous Property as May be Needed for said Purpose.

Blaine Mansion, authorizing alterations, improvements, etc. Resolved: That the governor and council be, and hereby are, authorized and instructed to make such alterations, improvements and repairs of the residence of the late James G. Blaine, recently given to the state by Mrs. Harriet Blaine Beale, as may appear to the governor and council to be
