Chapter 148.

Resolve, in Favor of Francois X. Belleau of Lewiston in the County of Androscoggin, for Services as Clerk of the Superior Court.

Francois X. Belleau, services as clerk of Androscoggin superior court. Resolved: That there be paid to Francois X. Belleau of Lewiston, in the county of Androscoggin, from the treasury of the county of Androscoggin on or before the first day of August, nineteen hundred and nineteen, the sum of twelve hundred dollars in full payment and discharge of services performed by the said Francois X. Belleau as clerk of the superior court for the county of Androscoggin from May, nineteen hundred and seventeen, to December thirty-first, nineteen hundred and eighteen, for the payment of which no provision of law had been made.

Chapter 149.

Resolve, in Favor of the Bangor Anti-Tuberculosis Association, Bangor, for the Care and Treatment of Persons Affected with Tuberculosis.

Bangor Anti-Tuberculosis Association, treatment of persons affected with tuberculosis. Resolved: That there be, and hereby is, appropriated to be paid to the Bangor Anti-Tuberculosis Association, Bangor, for the care and treatment of persons affected with tuberculosis, the sum of fifteen hundred dollars for the year nineteen hundred and nineteen and the sum of fifteen hundred dollars for the year nineteen hundred and twenty; provided, that any unexpended balance appropriated for the year nineteen hundred and nineteen shall be available for expenditure during nineteen hundred and twenty, in addition to the amount appropriated for said year.

Chapter 150.

Resolve, Providing for the Purchase of One Hundred Copies of the Centennial History of Presque Isle.

Centennial history Presque Isle, authorizing purchase of 100 copies of. Resolved: That the state librarian be, and hereby is, authorized to purchase for the state, when printed, one hundred copies of the centennial history of Presque Isle, Maine, by George M. Park, at five dollars per volume, to be distributed at the discretion of said state librarian; and that the sum of five hundred dollars be, and hereby is, appropriated for that purpose; provided that said history shall contain all the necessary records of the inhabitants of said Presque Isle, who served in the late war between the United States and the Central Powers.
