proposed in the foregoing resolution, and the question shall be: "Shall the constitution be amended as proposed by a resolution of the legislature providing for the issuing of state bonds for the purpose of paying a bonus to Maine soldiers and sailors in the war with Germany?" And the inhabitants of said cities, towns and plantations shall vote by ballot on said question; those favoring the amendment voting "Yes" and those opposed voting "No" upon their ballots; said ballots shall be sorted, counted and declared in open ward, town and plantation meetings, and returns made to the office of the secretary of state in the same manner as votes for governor and members of the legislature. And the governor and council shall count the same, and if it shall appear that a majority of the inhabitants voting on the question are in favor of the amendment, the governor shall forthwith make known the fact by a proclamation, and the amendment shall, as of the date of said proclamation, become a part of the constitution.

Secretary of state to furnish municipalities with copy of resolve. Resolved: That the secretary of state shall prepare and furnish to the several cities, towns and plantations, ballots and blank returns in conformity with the foregoing resolves accompanied by a copy thereof.

Chapter 174.

Resolve, in Favor of the Maine Institution for the Blind.

Appropriation for dormitory for Maine Institution for Bind, provided like amount be raised for same purpose within a year. Resolved: That there be appropriated the sum of thirty-seven thousand, five hundred dollars, for the purchase of a lot of land and the erection of a building thereon, to be used as a dormitory for the Maine Institution for the Blind; said sum to be paid out of any money in the treasury not otherwise appropriated, and expended under the direction of the governor and council. Providing, however, that a like amount shall be otherwise raised for the above stated purpose within one year from the date of approval of this resolve.

Chapter 175.

Resolve, Amending Chapter One Hundred Thirteen of the Resolves of Nineteen Hundred and Nineteen, Providing for the Care, Support and Medical or Surgical Treatment of Dependent Persons in or by Certain Charitable and Benevolent Institutions and Organizations Not Owned or Controlled by the State, and for Other Purposes.

Resolves 1919, c. 113, ¶ 15; relating to the medical and surgical treatment and care of children and adults, by certain charitable and benevolent institutions and organizations not controlled by the state. Resolved: That

the paragraph of chapter one hundred and thirteen of the resolves of nineteen hundred and nineteen which defines the classes of persons entitled to medical or surgical treatment, under the provisions of said chapter one hundred and thirteen, is hereby amended by striking out the words "fourteen dollars" in the ninth line thereof, and inserting instead the words, 'seventeen dollars and fifty cents,' so that said paragraph, as amended, shall read as follows:

'Maximum amount increased from \$14 to \$17.50 a week. For medical and surgical treatment and care of children,—including children under sixteen years of age, who are being supported away from their parents under the provisions of sections fifty-one to fifty-five inclusive, chapter sixty-four, revised statutes, and acts amendatory thereof, but not including persons sixteen years of age and over, who, directly or indirectly within a period of three months prior to receiving such treatment or care, have been supported or assisted under the provisions of chapter twenty-nine, revised statutes, and acts amendatory thereof,—at not to exceed seventeen dollars and fifty cents per week, including direct payments from sources other than the state.'

Not to apply to Children's Hospital. And, Resolved, further, that the aforesaid limitation as to the rate of charge per patient per week and the limitation contained in said chapter in the next to the last paragraph thereof as to the total amount which may be paid by the state shall not apply to the Children's Hospital for any part, whether elapsed or not, of the year nineteen hundred and nineteen or of the year nineteen hundred and twenty.

Chapter 176.

Resolve, to Reimburse Certain Members of First Maine Heavy Field Artillery for Expenses Incurred by Direction of Their Superior Officers.

Reimbursing certain members of First Maine Heavy Field Artillery for certain expenses incurred. Resolved: That the following sums of money be paid out of the fund for war purposes to the persons herein enumerated, for the purpose of reimbursing them, while members of the First Maine Heavy Field Artillery, for expenses incurred by direction of their superior officers, to wit:
