CHAP. 101

at the time he was commissioned, enlisted, inducted, appointed or mustered into the military or naval service of the United States, and who has been or may be given an honorable or ordinary discharge or release from such service, or who, if still in such service at the time of application for said bonus, may be given a certificate of good standing; provided, however, that the word "soldier," as used in this act, shall not be construed to mean, and shall not include any person who, at any time during the period of the war with Germany, sought to avoid service because of conscientious objections thereto, or because of alienage, or who has been at any time guilty of fraud or wilful violation or evasion of the Selective Service Act or of the rules or regulations of the war department in force thereunder.'

Sec. 2. 1919, c. 264, § 3; relating to the application for bonus by world war soldiers, amended. Section three of said chapter two hundred sixty-four is hereby amended by striking out after the words "on forms provided by him" in the second line thereof, all the rest of the sentence, and adding in place thereof the following: 'before the first day of January, nineteen hundred twenty-two'; so that said section, as amended, shall read as follows:

'Sec. 3. Extends the time during which application may be made to January 1st, 1922. Applications for such bonus shall be filed with the adjutant general, on forms provided by him, before the first day of January, nineteen hundred twenty-two. Such application shall state facts sufficient to establish the status of such applicant as soldier as defined herein, and shall be duly verified.'

Chapter 101.

An Act to Amend Section One of Chapter Sixty-two of the Revised Statutes as Amended by Chapter Forty-eight of the Public Laws of Nineteen Hundred and Nineteen, Relating to Corporations for Literary, Charitable, Educational and other Purposes.

Be it enacted by the People of the State of Maine, as follows:

R. S., c. 62, § 1; 1919, c. 48; relating to organization of corporations for charitable, educational and literary purposes, amended. Section one of chapter sixty-two of the revised statutes, as amended by chapter forty-eight of the public laws of nineteen hundred and nineteen, is hereby amended by inserting in the fifth line thereof after the word "Pythias" and before the word "as" the words 'as a tribe of the Improved Order of Red Men,' so that said section, as amended, shall read as follows:

'Sec. 1. Enumeration includes tribe of Improved Order of Red Men. When seven or more persons desire to be incorporated as proprietors

of a social, military, literary, scientific or county law library; as a Masonic lodge or chapter of any order or degree; as a Masonic association consisting of members of different orders or degrees; as a lodge of the Independent Order of Odd Fellows; as a lodge of the Knights of Pythias; as a tribe of the Improved Order of Red Men; as a division of the Sons of Temperance; as a tent of the Rechabites; as a grange of Patrons of Husbandry; as a council of the Sovereigns of Industry; as a Grand Army Post; as a relief or benefit association for mutual assistance; as a monument or memorial association; as a society to promote temperance; as a village improvement society; as an association for the promotion of good municipal government; as a chamber of commerce or board of trade; as a yacht club; or for any literary, scientific, musical, charitable, educational, social, military, agricultural, moral, religious, or benevolent purpose; they may apply in writing to any justice of the peace in the county, who may issue his warrant, directed to one of said applicants, requiring him to call a meeting thereof at such time and place as the justice may appoint.'

Chapter 102.

An Act to Amend Section One Hundred and Thirty-nine of Chapter Sixteen of the Revised Statutes as Amended, Relating to the Appropriation for Industrial Education.

Be it enacted by the People of the State of Maine, as follows:

R. S., c. 16, § 139; 1917, c. 77; 1919, c. 87; relating to appropriation for industrial education, amended. Section one hundred thirty-nine of chapter sixteen of the revised statutes, as amended by chapter seventy-seven of the public laws of nineteen hundred seventeen and by chapter eighty-seven of the public laws of nineteen hundred nineteen, is hereby further amended by striking out the words "seventy-five thousand dollars for the year nineteen hundred and nineteen and eighty thousand dollars for the year nineteen hundred and twenty" in the second, third and fourth lines thereof and substituting the words 'four thousand dollars for the period from January first, nineteen hundred twenty-one to June thirtieth, nineteen hundred twenty-one, and ninety thousand dollars for the year from July first, nineteen hundred twenty-one to June thirtieth, nineteen hundred twenty-two, and annually thereafter,' so that said section, as amended, shall read as follows:

'Sec. 139. Increasing the annual appropriation and making an appropriation for first six months to conform to change in fiscal year of state. For the purposes of the seven preceding sections there shall be deducted by the treasurer of state from the school and mill fund
