Chapter 177.

An Act to Amend Section Twenty-seven, Sub-Section Sixth, of Chapter Fifty-two of the Revised Statutes, Relating to Investments by Savings Banks in Railroad Equipment Obligations.

Be it enacted by the People of the State of Maine, as follows:

R. S., c. 52, § 27, sub-section sixth relating to the investment of the deposits of savings banks, supplemented. Chapter fifty-two, section twenty-seven, sub-section sixth, of the revised statutes is hereby amended by adding thereto the following paragraph which shall be known as paragraph "g":

'g. May invest two per cent of their deposits in railroad equipment obligations issued by the Northern Railway Service Corporation. Not exceeding two per cent of their deposits and surplus in the prior lien equipment obligations or equipment trust certificates issued by the National Railway Service Corporation in pursuance of any equipment trusts financed in whole or in part through a loan or loans made or approved by the interstate commerce commission, provided such securities are issued for not exceeding in par value sixty per cent of the cost of standard railway equipment and that such obligations shall mature in approximately equal annual or semi-annual instalments over a period not exceeding fifteen years.'

Chapter 178.

An Act to Amend Section Thirty-two of Chapter Two Hundred and Nineteen of the Public Laws of Nineteen Hundred and Seventeen, as Amended by Chapter One Hundred and Seventy-four of the Public Laws of Nineteen Hundred and Nineteen, Relating to Pollution of Waters of the State by Sawdust and Other Mill Waste.

Be it enacted by the People of the State of Maine, as follows:

R. S., c. 33, § 32; 1917, c. 219; 1919, c. 21 and 174; relating to the deposit of sawdust and other mill waste in lakes and streams, amended. Section thirty-two, of chapter two hundred and nineteen, of the public laws of nineteen hundred and seventeen, as amended by chapter one hundred and seventy-four, of the public laws of nineteen hundred and nineteen, is hereby amended by striking out all of said section and by substituting therefor the following section:

'Sec. 32. Brooks and streams in Sebago in Cumberland Co., Carrabasset River in Kingfield and New Portland, Alder Stream, Piscataquis River; tributaries of south branch of Piscataquis River in Abbot, Jimmie Brook in Cambridge, Medomak Stream
