CHAP. 200

#### Chapter 200.

An Act to Repeal Chapter Fifty-seven of the Public Laws of Nineteen Hundred and Twenty-one, Entitled "An Act to Provide Funds for Operating the Fish Hatcheries and Feeding Stations for Fish."

Emergency preamble. Whereas, under the suspension of the rules of the eightieth legislature an act was passed by said legislature and approved by the governor, March twenty-sixth, nineteen hundred and twentyone entitled "An Act to Provide Funds for Operating the Fish Hatcheries and Feeding Stations for Fish" which has become chapter fifty-seven of the public laws of nineteen hundred and twenty-one, and,

Whereas, said act carried the emergency clause and is now in full force and effect, and,

Whereas, the title to said act was misleading and no opportunity was given for a public hearing, and,

Whereas, by the foregoing facts an emergency exists as is contemplated by the constitution of the state, and the passage of this act is immediately necessary for the preservation of the public peace, health and safety, now, therefore,

Be it enacted by the People of the State of Maine, as follows:

Sec. 1. 1921, c. 57; increasing the fee for non-resident fishing licenses repealed. Chapter fifty-seven of the public laws of nineteen hundred and twenty-one, entitled, "An Act to Provide Funds for Operating the Fish Hatcheries and Feeding Stations for Fish" is hereby repealed.

Sec. 2. Emergency clause. In view of the emergency cited in the preamble, this act shall take effect when approved.

Approved April 9, 1921.

#### Chapter 201.
