## CHAP 2

and seventy-two of the public laws of nineteen hundred and seventeen, \$1,213,318.83, is hereby appropriated. All payments hereunder are to be charged to the regular appropriations for the same when made.

**Sec. 2. Emergency clause.** In view of the emergency cited in the preamble, this act shall take effect when approved.

Approved January 19, 1921.

## Chapter 2.

An Act to Amend Chapter One Hundred and Seventy-one of the Private and Special Laws of Eighteen Hundred and Seventy-nine, Entitled "An Act Amendatory to 'An Amended Act Incorporating the Kennebec Log Driving Company,' Approved March Fifth, Eighteen Hundred and Sixty-nine," as Amended by Chapter Fourteen of the Private and Special Laws of Nineteen Hundred and Seventeen.

*Be it enacted by the People of the State of Maine, as follows:*

**P. and S. L., 1879, c. 171, § 1; relating to tolls that may be charged by Kennebec Log Driving Co. for the passage of logs and lumber over its dams and improvements, amended.** Section one of chapter one hundred and seventy-one of the private and special laws of eighteen hundred and seventy-nine is hereby amended by inserting after the word "called" in the fifth line of said section the following: 'and immediately after the close of the drive on Moose River,' so that said section, as amended, shall read as follows:

**'Sec. 1. Moose River drive included.** The directors of said Kennebec Log Driving Company are hereby authorized to assess the tax for driving logs, contemplated in said charter, immediately after the close of the drive on Dead River and immediately after the close of the drive on the East Branch, so-called, and immediately after the close of the drive on Moose River and in anticipation in either of said assessments of the actual cost of driving on the Main River, so-called. And if after said logs and other timber shall have been driven and all expenses ascertained and estimated, it shall be found that said assessment shall be more than sufficient to pay said expenses, then the balance so remaining shall be by the directors refunded to said owner or owners, in proportion to said sum to them respectively assessed.'

## Chapter 3.

An Act to Extend an Act Entitled "An Act to Incorporate the Odd Fellows' Home of Maine."

*Be it enacted by the People of the State of Maine, as follows:*

**Charter of Odd Fellows Home of Maine, extended.** The act of incorporation of the Odd Fellows' Home of Maine, being chapter one hundred and ten of the private and special laws of nineteen hundred and

seventeen, and as extended two years by the provisions of chapter thirteen of the private and special laws of nineteen hundred nineteen, is hereby extended for two years from the date when this act becomes effective with the same force and effect in all respects as if said incorporation were hereby granted.

## Chapter 4.

An Act to Amend Section Three of Chapter Ninety-nine of the Private and Special Laws of Nineteen Hundred and Fifteen, Creating the Office of Corporation Counsel of the City of Portland.

*Be it enacted by the People of the State of Maine, as follows:*

**P. and S. L., 1915, c. 99, § 3; relating to the duties of the corporation counsel of the City of Portland, amended.** Section three of chapter ninety-nine of the private and special laws of nineteen hundred fifteen is hereby amended so that said section, as amended, shall read as follows:

**'Sec. 3. Salary to be fixed by city council; minimum limit, \$2500 a year.** Said corporation counsel shall be furnished a suitable office in the city hall. He shall give his entire time, during the hours when other offices in said city hall are open for the transaction of the city's business on secular days, to the duties of his office, and shall receive such salary as the city council shall determine, but said salary shall be not less than twenty-five hundred dollars per annum, payable in twelve equal monthly installments, together with an allowance for clerk hire, the amount to be fixed by the city council.'

## Chapter 5.

An Act to Ratify, Confirm and Make Valid the Doings of the Old Folks Home, in Bath, and the Home for Aged Couples and Old Men, in Consolidating the Homes for the Aged Maintained by them Severally.

*Be it enacted by the People of the State of Maine, as follows:*

**Consolidation of Bath Old Folks Home and Home for Aged Couples and Old Men made valid.** All the corporate acts and proceedings of the Old Folks Home, in Bath, and all the corporate acts and proceedings of the Home for Aged Couples and Old Men, done, transacted and performed in effecting the consolidation and union of the homes for the aged formerly maintained by each of said corporations, severally; and all grants, conveyances, assignments and transfers of its properties and funds, real and
