CHAP. 22

#### Chapter 22.

An Act to Amend Sections Two, Seven and Thirteen of Chapter One Hundred and Eighty of the Private and Special Laws of Eighteen Hundred and Sixty-nine, as Amended by Sections One, Two and Three of Chapter Five of the Private and Special Laws of Eighteen Hundred and Ninety-nine, Relating to Annual Meetings of Protestant Episcopal Churches of the Diocese of Moire

Be it enacted by the People of the State of Maine, as follows:

- Sec. 1. P. and S. L., 1869, c. 180, § 2; 1899, c. 5; relating to the annual meetings of Protestant Episcopal Churches, amended. Section two of "An act to Provide for the Organization of Parishes of the Protestant Episcopal Church in Maine," approved February twenty-six, eighteen hundred and sixty-nine, amended by section one of chapter five of the private and special laws of eighteen hundred and ninety-nine, is hereby further amended by striking out the last six words, namely: "in the first week in advent," and inserting in place thereof the words 'at such time in January as such parish shall designate,' so that said section, as amended, shall read as follows:
- Sec. 2. P. and S. L., 1869, c. 180, § 7; 1899, c. 5; relating to election of wardens and vestrymen of Protestant Episcopal Churches, amended. Section seven of said act, as amended by section two of said chapter five of the private and special laws of eighteen hundred and ninetynine, is hereby further amended by striking out the words "in the first week in advent as may have been agreed upon" and inserting in place thereof the words in January as such parish shall designate, so that said section, as amended, shall read as follows:
- 'Sec. 7. Meeting to be held at such time in January as parish shall designate. The annual meeting shall take place at such time in January as such parish shall designate, and at such annual meeting an election of the requisite number of wardens and vestrymen shall be had, to serve until the next annual meeting, and until their successors shall be chosen.'

- Sec. 3. P. and S. L., 1869, c. 180, § 13; 1899, c. 5; relating to reorganization of parishes of Protestant Episcopal Churches, amended. Section thirteen of said act, as amended by section three of chapter five of the private and special laws of eighteen hundred and ninety-nine, is hereby further amended by striking out the words "in the first week in advent" in the seventh line of said section and inserting in place thereof the words "in January," so that said section, as amended, shall read as follows:
- 'Sec. 13. Amended to conform with change in date of annual meeting. Upon such execution, acknowledgment and recording of such agreement, such parish shall, without further action, be deemed to all intents and purposes reorganized, and all rights of property and of contract shall remain unimpaired, and the corporate identity of such parish shall continue unchanged. The wardens and vestrymen in office shall continue therein until the annual election in January next following such reorganization, and until a new board shall be chosen, and no other meeting or notice shall be necessary to complete such reorganization; provided, that when a new board shall be chosen, it shall consist of the number of vestrymen required by such articles of reorganization.'

### Chapter 23.

An Act to Enable the City of Lewiston to Sell Water to the Town of Lisbon.

Emergency preamble. Whereas, the inhabitants of the town of Lisbon living in that part of the town, known as Lisbon Center and Lisbon Village, are without an adequate supply of pure water for domestic and public purposes, and whereas the supply of water for domestic and public purposes to the inhabitants of said town is an emergency measure immediately necessary for the preservation of the public peace, health and safety, now therefore,

Be it enacted by the People of the State of Maine, as follows:

- Sec. 1. P. & S. L., 1899, c. 153; authorizing city of Lewiston to take water for municipal and domestic purposes, amended. Chapter one hundred and fifty-three of the private and special laws of eighteen hundred and ninety-nine is hereby amended by adding to said chapter the following section:
- 'Sec. 6. May contract for sale of water to town of Lisbon. The city of Lewiston is hereby authorized to take water from Lake Auburn in sufficient quantities for the purpose of supplying water to the town
