Chapter 25.

An Act to Amend Chapter Three Hundred and Forty-nine of the Private and Special Laws of Nineteen Hundred and Five, Entitled "An Act Relating to Pensioning Members of the Police Department of the City of Bangor."

Be it enacted by the People of the State of Maine, as follows:

P. & S. L., 1905, c. 348, § 1; relating to pensions for members of Police Department for city of Bangor. amended, Section one of chapter three hundred and forty-nine of the private and special laws of nineteen hundred and five is hereby amended by striking out the whole of the first paragraph thereof and substituting therefor the following paragraph:

'A pension is hereby provided for, to be paid by the city of Bangor to the following members of the police department of said city, said pension to be equal, at any given time, to one-half the regular pay at that time received by patrolmen in said department; all pension payments made under the provisions of this section to be automatically increased or diminished in amount by increases or reductions in the daily pay allowed by the city council to regular patrolmen in said department', and by striking out the words "shall be" in the first line of the second paragraph thereof and substituting therefor the words 'has been or shall have been', and by striking out all of the third paragraph thereof and substituting therefor the following paragraph:

'Second: To any member of said department who has or shall have performed faithful service therein for a period of not less than twenty years, if the police examining board of said city has or shall have certified that such member has become incapacitated for further useful service in said department,' so that said section, as amended, shall read as follows:

'Sec. 1. Amount of pension and conditions under which it may be granted, changed. A pension is hereby provided for, to be paid by the city of Bangor to the following members of the police department of said city, said pension to be equal, at any given time, to one-half the regular pay at that time received by patrolmen in said department; all pension payments made under the provisions of this section to be automatically increased or diminished in amount by increases or reductions in the daily pay allowed by the city council to regular patrolmen in said department:

'First: To any member of said department who has been or shall have been certified to the city council of said city, in writing, by the city physician of said city or, if required by the city council, by a majority of a disinterested board of physicians appointed by the police examining board

of said city, as being permanently incapacitated, either mentally or physically, by injuries sustained through no fault of his in the actual performance of duty, for further performing duty as such member.

'Second: To any member of said department who has or shall have performed faithful service therein for a period of not less than twenty years, if the police examining board of said city has or shall have certified that such member has become incapacitated for further useful service in said department.'

Approved March 10, 1921.

Chapter 26.

An Act to Authorize the Construction of a Weir in the Tidewaters of What Was Formerly Muscle Ridge Plantation in the County of Knox.

Be it enacted by the People of the State of Maine, as follows:

Sec. 1. Wm. Underwood Company authorized to construct fish weir at Muscle Ridge. Wm. Underwood Company, a corporation duly organized and existing by law, and its assigns, are hereby authorized to build and maintain a fish weir in the tidewaters of what was formerly Muscle Ridge Plantation in the county of Knox; provided said weir does not interfere with navigation or with the rights of others.

Sec. 2. Location and specifications. The above mentioned weir shall be located as follows, to wit: the pound is to be located about five hundred feet, west by south, three-quarters south from Dix Island, and to be about six hundred feet in circumference, with one leader extending east by north, three-quarters north, four hundred feet, and one leader extending north by east, two hundred feet; with pocket to be attached to the north side of said pound and to be about sixty feet square.

Chapter 27.

An Act to Authorize the Construction of a Weir in the Tidewaters of Roque Harbor in the Town of Jonesport.

Be it enacted by the People of the State of Maine, as follows:

Sec. 1. Oscar W. Look authorized to maintain fish weir in Roque Harbor. Oscar W. Look of Jonesport, in the county of Washington, is hereby authorized to build and maintain a weir for fishing purposes in the tidewaters of Roque Harbor in said Jonesport, providing said weir does not interfere with navigation or the rights of others.
