## Chapter 41.

An Act to Authorize the Town of Rangeley to Acquire the Wharves in Rangeley Lake of the Rangeley Lakes Steamboat Company.

*Be it enacted by the People of the State of Maine, as follows:*

**Town of Rangeley authorized to purchase property and rights of Rangeley Lakes Steamboat Co. through municipal officers of said town.** The town of Rangeley, in the county of Franklin, is hereby authorized and empowered to purchase, and the Rangeley Lakes Steamboat Company, a corporation duly established and existing under the laws of the state, is hereby authorized to sell and convey to said town of Rangeley, the wharves, together with all the rights and privileges connected therewith, owned by said company, and situate in Rangeley Lake in said town of Rangeley, described as follows: The wharf commencing at the southerly end of Lake Street in Rangeley village in said town of Rangeley and extending into the waters of said Rangeley Lake; also the wharf, near the foot of Rangeley Lake in the town of Rangeley aforesaid, commencing at the end of the road leading from Haines Landing to Rangeley Outlet wharf and extending into the waters of said lake.

Said town of Rangeley, by its municipal officers, when duly authorized by a vote of the inhabitants of said town, and said Rangeley Lakes Steamboat Company are hereby authorized and empowered to enter into a mutual written agreement for the purchase and sale of said property upon such terms as may be agreed upon by said town and said company.

## Chapter 42.

An Act to Protect the Water Supply of the Town of East Livermore.

*Be it enacted by the People of the State of Maine, as follows:*

**Sec. 1. Fishing in Moose Hill Pond prohibited.** No person shall at any time in the year fish in the waters of Moose Hill Pond in the town of East Livermore in the county of Androscoggin.

**Sec. 2. Penalty for violation.** Any person violating section one of this act shall be punished by a fine of not less than ten dollars nor more than twenty dollars and costs for each offense.

**Sec. 3. Court jurisdiction.** Municipal courts and trial justices shall have jurisdiction of each offense under this law.
