Chapter 63.

An Act to Amend the Charter of the Mutual Fire Insurance Company of Saco, Maine.

Be it enacted by the People of the State of Maine, as follows:

P. & S. L., 1827, c. 485, § 3; relating to the Mutual Fire Insurance Company of Saco, amended. Section three, of chapter four hundred and eighty-five of the private and special laws for the year eighteen hundred and twenty-seven incorporating the Mutual Fire Insurance Company of Saco, is hereby amended by inserting after the word "state" in the fourth line, the words, 'or any other state' so that said section, as amended, shall read as follows:

'Sec. 3. Territory not confined to this state. Be it further enacted, that said corporation may insure for any term from one to ten years, any house or other building in this state, or any other state, household furniture and goods, against damage arising to the same by fire, originating in any cause, other than by design in the insured, and to any amount not exceeding three-fourths of the value of the property insured. And in case any member shall sustain damage by fire over and above the then existing funds of the corporation, the corporation, or such of its officers as shall by vote be designated for that purpose, shall assess such further sum or sums upon each member, as may be in proportion to the sum by such member insured, and at the rate of hazard originally agreed on.'

Chapter 64.

An Act to Extend the Charter of the R. and T. Cement Railroad.

Be it enacted by the People of the State of Maine, as follows:

Charter extended. The charter of the R. and T. Cement Railroad, as granted by chapter one hundred and ninety of the private and special laws of nineteen hundred and nine, is hereby renewed and extended for a period of two years. The acceptance of said charter and organization under the same heretofore made are hereby approved. All proceedings heretofore legally taken as provided in said charter or in conformity with the statutes of this state are hereby ratified and confirmed and the validity of the same likewise renewed and extended.
