CHAP, 65

Chapter 65.

An Act to Authorize the Auburn Water Commissioners to Sell Certain Real Estate.

Be it enacted by the People of the State of Maine, as follows:

Authorizing sale of certain real estate purchased from Albert F. Hutchinson. The Auburn Water Commissioners, a corporation created by special act of the legislature of Maine, and located at Auburn, Maine, is authorized to sell so much of the real estate, including lands and buildings, purchased by said corporation from Albert F. Hutchinson, as in the judgment of the commissioners of said corporation shall not be needed for the uses and purposes for which said corporation was organized.

Approved March 22, 1921.

Chapter 66.

An Act to Amend Section Three of Chapter Three Hundred and Seventy of the Private and Special Laws of Nineteen Hundred and Nine, Relating to Police Department of the City of Portland.

Be it enacted by the People of the State of Maine, as follows:

- P. & S. L., 1909, c. 370, § 3; relating to the classification of policemen of the Portland police department, amended. Section three of chapter three hundred seventy of the private and special laws of nineteen hundred and nine relating to police department of the City of Portland is hereby amended by striking out said section and inserting the following:
- 'Sec. 3. More clearly specifying classification. The city council of the City of Portland may by ordinance classify policemen, in the manner following:

First Grade. Inspectors who shall rank as lieutenants.

Second Grade. Sergeants.

Third Grade. Patrolmen.

No person shall be appointed to the grade of inspector or sergeant unless he shall be a regular officer of the police force.'

Chapter 67.

An Act to Make Legal and Valid the Annual City Election of the City of Ellsworth, held March First, Nineteen Hundred and Twenty.

Emergency preamble. Whereas, it is necessary to enforce the collection of the taxes assessed in the City of Ellsworth, in Hancock county,

for the year nineteen hundred twenty, in order to provide funds to carry on the business affairs of the city; and to make valid the proper and necessary acts of the municipal officers of this city; and,

Whereas, these facts render the passage of this act immediately necessary for the preservation of the public health, peace and safety, and, constitute an emergency within the meaning of the constitution, now therefore,

Be it enacted by the People of the State of Maine, as follows:

- Sec. 1. City election of Ellsworth, March, 1920, made valid. The annual city election of the City of Ellsworth, in the County of Hancock, held in said city on March first, A.D. nineteen hundred and twenty, is hereby legalized and made valid.
- Sec. 2. Emergency clause. In view of the emergency cited in the preamble, this act shall take effect when approved.

Approved March 22, 1921.

Chapter 68.

An Act to Legalize and Make Valid the Proceedings of the Town Meeting of the Town of Manchester, in the County of Kennebec, held on the Seventh Day of March, One Thousand Nine Hundred and Twenty-one.

Emergency preamble. Whereas, an emergency exists, because it is immediately necessary for the preservation of the public peace and safety, that the acts and doings of the inhabitants of the Town of Manchester at the annual town meeting, held March seventh, one thousand nine hundred and twenty-one, be made legal and valid without delay, therefore,

Be it enacted by the People of the State of Maine, as follows:

- Sec. 1. Manchester town meeting, March, 1921, made valid. The town meeting of the Town of Manchester, in the County of Kennebec, held on the seventh day of March, one thousand nine hundred and twenty-one, is hereby ratified and made legal and valid and all the proceedings of said meeting are hereby ratified, confirmed and made legal and valid.
- Sec. 2. Emergency clause. In view of the emergency cited in the preamble, this act shall take effect when approved.

Approved March 23, 1921.

Chapter 69.

An Act to Authorize the American Realty Company to Construct and Maintain a Dam across the Aroostook River in Washburn.

Be it enacted by the People of the State of Maine, as follows:
