JUDGE OF GARDINER MUNICIPAL COURT.

CHAP. 145

Sec. 9. Salary of superintendent of streets and clerk of commission. The compensation of the superintendent of streets and sewers, and also that of the clerk or clerks shall be fixed by said commissioners and shall be paid from an appropriation made by the city council for the work of the commission.

Sec. 10. Members of commission to be appointed by mayor; filling of vacancies; organization of commission; mayor to appoint chairman in case of no choice; city solicitor attorney for commission. Members of the commission shall be appointed by the mayor, one for a term of six years, one for five years, and one for four years. Vacancies occurring during a term shall be filled for the unexpired term. The commission shall annually choose a chairman from its members, and in case of failure to make such choice, the mayor shall appoint the chairman. The city solicitor shall be attorney for said commission and shall without additional compensation give the commission such advice and service as it may from time to time require.

Sec. 11. Procedure for removal of commissioners. Proceedings for removal of said commissioners shall be brought on petition of a majority of the city council and shall be heard as provided in section two of this act, the decision of the justice hearing a petition for removal shall be final.

Sec. 12. Inconsistent statutes repealed. All acts and parts of acts inconsistent with this act are hereby repealed.

Chapter 145.

An Act to Increase the Salary of the Judge of the Municipal Court in Gardiner,

Be it enacted by the People of the State of Maine, as follows:

P. & S. L., 1911, c. 247, § 10; relating to the salary of the judge of the Gardiner Municipal Court, amended. That section ten of chapter two hundred and forty-seven of the Private and Special Laws of nineteen hundred and eleven, entitled "An Act with reference to the Gardiner Municipal Court," be amended, so that said section shall read as follows:

'Sec. 10. Salary increased to \$1200. The salary of said judge shall be twelve hundred dollars and such fees as are allowed by the general law, and the same shall be payable quarterly out of the treasury of the County of Kennebec, on the first day of January, April, July and October. All fines and costs received in criminal cases, shall be paid quarterly into

the county treasury; and no salary shall be paid to said judge until he shall file with the county treasurer, a written statement of the fines and criminal costs by him received during and for the preceding quarter.'

Chapter 146.

An Act to Amend Chapter One Hundred Eighty-eight of the Private and Special Laws of Nineteen Hundred Fifteen Entitled "An Act to Confer Additional Rights and Powers upon the East Branch Improvement Company, a Corporation Incorporated by a Special Act of the Legislature, Approved March Eighteenth, Nineteen Hundred Three."

Be it enacted by the People of the State of Maine, as follows:

Sec. 1. P. & S. L., 1915, c. 188, § 1; relating to tolls that may be demanded by the East Branch Improvement Company, for the passage of logs, amended. Section one of chapter one hundred eightyeight of the private and special laws of nineteen hundred fifteen is hereby amended by inserting after the word "river" in the seventh line of said section one the words 'coming through Grand Lake Dam of twenty-five cents for each thousand feet board measure, and for logs and lumber'; also by striking out in the tenth line the word "ten" and inserting in place thereof the words 'twelve and one-half'; also by striking out the word "five" in the fifteenth line and inserting in place thereof the words 'six and one-fourth'; also by inserting after the word "Medway" at the end of said section the words 'in computing tolls for lumber cut in short lengths for stave or pulp material or similar purposes two cords shall be reckoned to constitute one thousand feet board measure,' so that said section, as amended, shall read as follows:

'Sec. 1. Tolls increased and schedule established for passage through Grand Lake Dam; how tolls for lumber cut in short lengths shall be computed. The East Branch Improvement Company, a corporation incorporated by special act of the legislature of Maine entitled "An Act to Incorporate the East Branch Improvement Company," approved March eighteenth, nineteen hundred three, is hereby authorized and empowered to demand and receive a toll on all logs and lumber driven down the East Branch of the Penobscot river coming through Grand Lake dam of twenty-five cents for each thousand feet board measure, and for logs and lumber coming into said river below Grand Lake dam and the destination of which is below the junction of the East and West branches of said Penobscot river using stored water as follows: Twelve and one-half cents for each thousand feet board measure on all logs and lumber landed in or driven into said river between Grand Lake dam and a line drawn across township number three, range seven, west of east line of state,
