CHAP. 42

and thirteen of the resolves of nineteen hundred and nineteen, the sum of seven hundred and sixty-eight dollars and fifty-six cents, (\$768.56).

Approved April 1, 1921.

Chapter 42.

Resolve, to Reimburse the Town of Southport for the Expenses of the Sickness and Burial of Lydia A. Rowe.

Southport, burial soldiers and sailors. Resolved: That there be paid to the Town of Southport from the nineteen hundred and twenty-one appropriation for burial expenses of soldiers and sailors the sum of ninety-nine dollars, to reimburse the Town of Southport for the expenses of the last sickness, and funeral of Lydia A. Rowe, widow of James R. Rowe, a civil war veteran.

Approved April 1, 1921.

Chapter 43.

Resolve, to Increase the Pension Granted to Harmon Varrell of York.

Harmon Varrell, pension increased. Resolved: That there be paid to Harmon Varrell of York from the appropriation for soldiers' pensions the sum of ten dollars a month; the same to be in lieu of the pension now received by said Varrell.

Approved April 1, 1921.

Chapter 44.

Resolve, Reimbursing the Town of Oakland for Money Expended on Account of Mothers with Dependent Children.

Oakland, mother's pension. Resolved: That there be paid to the Town of Oakland from the nineteen hundred and twenty-one appropriation for aid to mothers with dependent children the sum of one hundred and fifty-six dollars and forty cents, for the purpose of reimbursing said town for money expended on account of Louise M. Shaw and her dependent children and Margie E. Spaulding and her dependent children, in the year nineteen hundred and eighteen, and that the state treasurer be and hereby is authorized to pay and deliver said sum of one hundred and fifty-six dollars and forty cents to the treasurer of said Town of Oakland.

Chapter 45.

Resolve, to Reimburse the Town of Mapleton.

Mapleton, neglected children. Resolved: That there be paid to the Town of Mapleton from the nineteen hundred and twenty-one appro-

priation for board and care of neglected children the sum of seventy-two dollars and thirteen cents to reimburse said town for money paid to the Maine Children's Home Society for the care of Whitlock's children during the months from June to December, nineteen hundred and nineteen.

Approved April 1, 1921.

Chapter 46.

Resolve, in Favor of C. K. Hopkins of Camden, Maine, for Labor Performed at Camden Fish Hatchery.

C. K. Hopkins, labor performed at Camden Fish Hatchery. Resolved: That there be paid to C. K. Hopkins, of Camden, Maine, from the money received from non-resident fishing licenses for nineteen hundred and twenty-one the sum of forty-four dollars and ninety cents, for labor performed at the Camden Fish Hatchery during the year of nineteen hundred and fourteen.

Chapter 47.

Resolve, in Favor of J. Wilbur Day, of Wesley, County of Washington, for Reimbursement for Cattle Killed by Bears.

J. Wilbur Day, cattle killed by bears. Resolved: That there be paid to J. Wilbur Day of Wesley, in the County of Washington, from the fund received for dog licenses the sum of two hundred and thirty dollars as compensation to said Day for the destruction of cattle killed by bears in Townships number thirty-one and thirty-seven in Washington county.

Approved April 1, 1921.

Chapter 48.

Resolve, to Reimburse the Town of Rumford for Aid Furnished Dependents of Soldiers.

Rumford, soldiers' dependents. Resolved: That there be paid to the treasurer of the Town of Rumford from the fund for aid to dependent families of soldiers and sailors the sum of one hundred and twenty-two dollars and ninety-six cents, to reimburse said town for aid furnished certain dependents of soldiers as follows:

Aid furnished on account Verle Sweatt to Mrs. Nettie K. Sanborn, for the months of January, February and March, nineteen hundred and nineteen, amounting to fifty-one dollars and forty-two cents.

Aid furnished on account Harry B. Armour to Mrs. Hannah O'Brien,
