## Chapter 55.

Resolve, in Favor of the Town of Boothbay Harbor for Military Aid Furnished the Wife of Herbert H. Thurston and Four Minor Children under Age of Fifteen Years.

**Boothbay Harbor, soldiers' dependents. Resolved:** That there be paid to the Town of Boothbay Harbor from the fund for the dependent families of soldiers and sailors, the sum of five hundred and twenty dollars to reimburse the said Town of Boothbay Harbor for military aid furnished Ruth C. Thurston, wife of Herbert H. Thurston; Louise H. Thurston, aged five years; Carolyn E. Thurston, aged four years; Edward H. Thurston, aged three years; Lillian M. Thurston, aged two years, minor children of said Herbert H. Thurston.

## Chapter 56.

Resolve, Providing for Certain State Pensions.

**State pensions. Resolved:** That the persons named on the following list be paid the amounts set opposite their respective names from the appropriation for soldiers' pensions, from the first day of January, nineteen hundred and twenty-one, until otherwise provided by the legislature:

## Chapter 57.

Resolve, in Favor of Lorenzo D. Wright of Montville for State Pension.

**Lorenzo D. Wright, state pension. Resolved:** That there be paid to Lorenzo D. Wright of Montville, the sum of eight dollar per month, payable quarterly, from the fund appropriated for soldiers' pensions, beginning January first, nineteen hundred twenty-one, and continuing during the pleasure of the legislature; which said payment shall be in lieu of payment under chapter one hundred seventeen of the resolves of nineteen hundred seventeen, and payment under said chapter shall be discontinued.

## Chapter 58.

Resolve, Authorizing the Governor and Council to Adjust Claims for Damages Caused by Flowage on Indian Island in the Penobscot River.

**Flowage damages, Old Town Indian Island. Resolved:** That the governor and council be, and hereby are, authorized and empowered to adjust all claims for damages to lands, highways and bridges on Indian Island, or Island Number One, so-called, in the Penobscot river, occasioned by flowage of the same by the Bangor Railway and Electric Company, and all sums received in settlement therefor are hereby appropriated, in addition to all other appropriations, for the purpose of maintenance and repair of highways and bridges on said island for the benefit of the Penobscot Tribe of Indians.

Resolve, to Reimburse the Town of South Thomaston for Amount Paid for Free High School Tuition for Year Ending July First, Nineteen Hundred and Nineteen.

**South Thomaston, High School tuition. Resolved:** That there be paid to the Town of South Thomaston, out of the state treasury, the
