CHAP. 71.

Andrew H. Morong of Portland, Maine, for services rendered to State of Maine in investigating cases for the local registration boards for soldiers, under the order of the adjutant general of the State of Maine, arresting delinquents and deserters and taking them to Camp Devens.

Approved April 5, 1921.

Chapter 71.

Resolve, in Favor of Sarah W. Pike for Services as Stenographer of the Committee on Judiciary.

Sarah W. Pike, stenographer, committee on judiciary. Resolved: That there be, and hereby is, appropriated the sum of two hundred and fifty dollars to be paid to Sarah W. Pike, stenographer to the committee on judiciary, for services during the eightieth session of the Maine legislature.

Approved April 5, 1921.

Chapter 72.

Resolve, in Favor of the Clerk, Stenographer and Messenger to the Committee on Inland Fisheries and Game.

Myrtle H. Hodgdon, Thomas A. James, clerk and messenger committee on inland fisheries and game. Resolved: That the sum of one hundred and fifty dollars be and is hereby appropriated to be paid to Myrtle H. Hodgdon, of Augusta, Maine, for services as clerk and stenographer to the committee on inland fisheries and game of this legislature, and that the sum of fifty dollars be and is hereby appropriated to be paid to Thomas A. James, of Augusta, Maine, for services as messenger to said committee, said appropriations to be paid from the appropriation for expenses of this legislature.

Chapter 73.

Resolve, Authorizing the State Land Agent to Sell Certain Public Lots in Lakeville Plantation in Penobscot County.

Authorizing sale of lots in Lakeville plantation. Resolved: That the land agent, with the advice and consent of the governor and council, is hereby authorized to sell and convey to actual settlers thereon, certain lands in Lakeville Plantation, in Penobscot county, constituting part of the school lots of said plantation, if he deem advisable, for such price per acre and on such terms of payment as he may deem advantageous; provided, that in making sales of said lands, the equitable rights of persons claiming under said settlers shall be considered and preserved; and pro-

vided, also, that the proceeds of any sales made shall be added to the school funds of said plantation; and it is further provided that not over one hundred acres will be conveyed to one settler.

Chapter 74.

Resolve, in Favor of the Town of Milo, for Aid to Mothers with Dependent Children.

Milo, mothers' pension. Resolved: That there be paid to the Town of Milo from the nineteen hundred and twenty-one appropriation for aid to mothers with dependent children the sum of eighteen dollars to reimburse said town for money paid to Mrs. Charlotte Cochrane.

Chapter 75.

Resolve, to Provide for Payment of Seed Lobsters Purchased in Nineteen Hundred Twenty.

Seed lobsters 1920. Resolved: That there be and hereby is appropriated the sum of thirteen hundred thirty-five dollars and ninety-one cents to pay for seed lobsters purchased during the year nineteen hundred twenty, the bills for which were not presented seasonably to be paid during that year.

Chapter 76.

Resolve, Reimbursing Plantations because of Reduction in the Rate of Interest Paid by the State to Plantations on their Wild Land School Funds.

Interest on wild land school funds, reimbursing certain plantations on account of reduction in interest. Resolved: That there be paid the sum of three thousand, three hundred and eighty-four dollars and fifty-three cents to the following plantations as listed below, on account of reduction in the rate of interest paid by the state to plantations on their wild land school funds, for a period from January first, nineteen hundred and nineteen, to July first, nineteen hundred and nineteen, to be taken from interest on lands reserved for public uses fund.
