## CHAP. 118

For the placing and maintenance of buoys on the Lower Lakes, so-called, to wit: North Twin Lake, North Twin Thoroughfare, South Twin Lake, South Twin Thoroughfare, Pemadumcook Lake, Pemadumcook Thoroughfare, Ambajejis Lake and Ambajejis Thoroughfare.	200.00
For the placing and maintenance of buoys on Lewy, Long and Big Lakes in Washington county.	100.00
For aid of navigation on Rangeley, Mooselucmeguntic and Cup-suptic Lakes.	200.00

**Balance to be continued.** Any appropriation herein named or part thereof not expended during the fiscal year of nineteen hundred and twenty-two shall be available during the fiscal year nineteen hundred and twenty-three.

## Chapter 118.

Resolve, to Reimburse the Members of the Special Committee Charged with the Duty of Investigating the Desirability of Enacting the Act Introduced at the Seventy-ninth Legislature Entitled "An Act to Establish the State University of Maine and to Provide for its Maintenance."

**Expenses of committee of 79th legislature to investigate act relative to establishment of State University. Resolved:** That there be and hereby is, appropriated the sum of one hundred seventy dollars and thirty-seven cents, for the purpose of paying the expenses of the commission created by the seventy-ninth legislature, to consider the relations of the state and the University of Maine; same to be paid from funds appropriated for legislative expense.

## Chapter 119.

Resolve, in Favor of Faith A. Tryon, for Services as Stenographer to the Committee on Redistricting the State.

**Faith A. Tryon, stenographer committee on redistricting state.**

**Resolved:** That there be, and hereby is, appropriated the sum of fifteen

dollars to be paid to Faith A. Tryon for services as stenographer to the committee on re-districting the state.

## Chapter 120.

Resolve, to Reimburse the Members of the Taxation Commission for Expenses.

**Expenses committee of 79th legislature to revise inheritance tax and probate laws. Resolved:** That there be, and hereby is, appropriated the sum of two hundred forty-four dollars and sixty-five cents, for the purpose of paying the expenses of the commission on taxation created by the seventy-ninth legislature. Same to be paid from the fund appropriated for legislative expense.

## Chapter 121.

Resolve, in Favor of F. G. Farrington, Chairman of the Committee on Insane Hospitals.

**Expense committee on Insane Hospitals. Resolved:** That there be and hereby is appropriated the sum of fifty-four dollars and twenty-three cents (\$54.23) to be paid to F. G. Farrington, chairman of the committee on insane hospitals of the eightieth legislature for money paid by him for expenses of said committee incurred in visiting the insane hospital at Bangor.

## Chapter 122.

Resolve, Dividing the State into Senatorial Districts.

**Apportionment of senatorial districts. Resolved:** That for the eighty-first legislature and the succeeding legislatures to and including that of the year nineteen hundred and thirty-one, the state be, and hereby is, divided into sixteen districts for the choice of senators, and each district shall be entitled to elect the number of senators herein provided, in the manner prescribed by the constitution.

**The County of York** shall form the first district, and be entitled to elect three senators.
