**Emergency.** Whereas, the appropriations specified in this resolve, applying to the first fiscal period named herein, are immediately necessary for the continued operation of this institution and thereby make this an emergency measure necessary for the preservation of the public peace, health and safety, therefore, be it

**Resolved,** that this resolve shall take effect when approved.

Approved April 9, 1921.

## Chapter 129.

Resolve, in Favor of the Western Maine Sanatorium.

**Emergency preamble.** Whereas no regular appropriation is available until ninety days after the adjournment of the legislature making the same, and

Whereas funds are necessary for personal services at and maintenance of the Western Maine Sanatorium, or the said sanatorium will have to be closed, and

Whereas the need for the maintenance of said sanatorium is an emergency immediately necessary for the preservation of the public peace, health and safety, therefore

**Western Maine Sanatorium, personal services, maintenance and repairs. Resolved:** That there be and there hereby is appropriated for the Western Maine Sanatorium:

<b>For personal services</b> for the fiscal period from January first to June thirtieth, nineteen hundred and twenty-one, the sum of twenty thousand dollars.	\$20,000.00
<b>For maintenance</b> during said fiscal period, the sum of fifty-seven thousand one hundred dollars.	57,100.00
<b>Personal services,</b> for the year ending June thirtieth, nineteen hundred and twenty-two, for personal services the sum of forty thousand dollars.	40,000.00
<b>For maintenance,</b> repairs and improvements for said second fiscal period, the sum of one hundred fourteen thousand and five hundred dollars.	114,500.00
<b>Personal services,</b> for the year ending June thirtieth, nineteen hundred and twenty-three, for personal services the sum of forty thousand dollars.	40,000.00

**CHAP. 130**

**For maintenance, repairs and improvements** for said third fiscal period, the sum of one hundred fourteen thousand and five hundred dollars. 114,500.00

**Unexpended balance continued.** Provided that the balance of any of the sums above appropriated, which may remain unexpended at the end of the fiscal period for which appropriated, may be available for expenditure for improvements and repairs during the succeeding fiscal period, if so ordered by the governor and council, and provided further, that the governor and council may, by order, upon the recommendation of the trustees of said institution, authorize the transfer of the unexpended balance of any of the above appropriations to any other appropriation for said institution.

**Emergency.** In view of the emergency cited in the preamble, this act shall take effect when approved.

Approved April 9, 1921.

## Chapter 130.

Resolve, in Favor of Charles J. Dain, Secretary of Committee on School for Feeble-minded.

**Expenses legislative committee, School for Feeble-minded. Resolved:** That there be and hereby is appropriated the sum of forty dollars to be paid to Charles J. Dain, secretary of the committee on School for Feeble-minded for expenses incurred in connection with the visit of said committee to Pownal.

Approved April 9, 1921.

## Chapter 131.

Resolve, in Favor of Richard T. Dunning, Secretary to Committee on State School for Boys, State School for Girls and State Reformatories.

**Expenses legislative committee juvenile institutions and state reformatories. Resolved:** That there be paid to Richard T. Dunning, secretary to committee on state school for boys, state school for girls and state reformatories, the sum of one hundred five dollars and thirty-seven cents for expenses of above committee as per schedule submitted:
