CHAP. 130

For maintenance, repairs and improvements for said third fiscal period, the sum of one hundred fourteen thousand and five hundred dollars. 114,500.00

Unexpended balance continued. Provided that the balance of any of the sums above appropriated, which may remain unexpended at the end of the fiscal period for which appropriated, may be available for expenditure for improvements and repairs during the succeeding fiscal period, if so ordered by the governor and council, and provided further, that the governor and council may, by order, upon the recommendation of the trustees of said institution, authorize the transfer of the unexpended balance of any of the above appropriations to any other appropriation for said institution.

Emergency. In view of the emergency cited in the preamble, this act shall take effect when approved.

Resolve, in Favor of Charles J. Dain, Secretary of Committee on School for Feeble-minded.

Expenses legislative committee, School for Feeble-minded. Resolved: That there be and hereby is appropriated the sum of forty dollars to be paid to Charles J. Dain, secretary of the committee on School for Feeble-minded for expenses incurred in connection with the visit of said committee to Pownal.

Resolve, in Favor of Richard T. Dunning, Secretary to Committee on State School for Boys, State School for Girls and State Reformatories.

Expenses legislative committee juvenile institutions and state reformatories. Resolved: That there be paid to Richard T. Dunning, secretary to committee on state school for boys, state school for girls and state reformatories, the sum of one hundred five dollars and thirty-seven cents for expenses of above committee as per schedule submitted:
