Chapter 150.

Resolve, in Favor of the Augusta State Hospital for Maintenance During the Years Nineteen Hundred and Twenty-one, Nineteen Hundred and Twenty-two and Nineteen Hundred and Twenty-three.

Emergency preamble. Whereas the institution hereinafter referred to cannot be properly and adequately maintained for the period ending June thirtieth, nineteen hundred and twenty-one, without assistance from the state, and whereas the proper maintenance of said institution is urgently necessary in the interest of the public peace, health and safety, and in the judgment of this legislature an emergency exists within the meaning of the constitution of this state; now, therefore, be it

Augusta State Hospital, maintenance and other purposes.

Resolved: That there be, and hereby is, appropriated for the Augusta State Hospital:

For personal services, namely, for salaries and wages of all officers and employees, for two years and one-half, January first, nineteen hundred and twenty-one, to June thirtieth, nineteen hundred and twenty-one, the sum of eighty thousand dollars; July first, nineteen hundred and twenty-one, to June thirtieth, nineteen hundred and twenty-two, the sum of one hundred sixty thousand dollars; July first, nineteen hundred and twenty-two to June thirtieth, nineteen hundred and twenty-three, the sum of one hundred and sixty thousand dollars.

equipment and livestock, and for general expenses; January first, nineteen hundred and twenty-one to June thirtieth, nineteen hundred and twenty-one, the sum of one hundred and ten thousand, eight hundred and eighty-seven dollars and thirteen cents; the period July first, nineteen hundred and twenty-one to June thirtieth, nineteen hundred and twenty-two, the sum of two hundred twenty-one thousand, seven hundred and seventy-four dollars and twenty-five cents; July first, nineteen hundred and twenty-two to June thirtieth, nineteen hundred and twenty-three, the sum of two hundred twenty-one thousand, seven hundred and seventy-four dollars and twenty-five cents.

Balance to be continued. Provided, that any balance of the sums above appropriated for the period January first to June thirtieth, nineteen hundred and twenty-one, which may remain unexpended at the end of the six months, shall be available for expenditures during the year following, and that any balance of the sums above appropriated for the year, July first, nineteen hundred and twenty-one to June thirtieth, nineteen hundred and twenty-two, which may remain unexpended at the end of the year, shall be available for expenditures during the year following, and provided further, that the governor and council may, by order, upon recommendation of the trustees of the said institution, authorize the use of any unexpended balance in any of the items contained in the above appropriation, to apply toward any deficiency that may exist in any other.

Emergency clause. In view of the emergency cited above, this resolve shall take effect when approved.

Chapter 151.

Resolve, to Reimburse the Town of Prentiss for Sheep and Poultry Killed by Dogs and Wild Animals in Nineteen Hundred and Nineteen.

Prentiss, sheep and poultry killed by dogs and wild animals. Resolved: That there be, and hereby is, appropriated the sum of seven hundred ninety dollars and fifty cents to be paid to the Town of Prentiss,
