## CHAP. 160

Making a total of fourteen thousand one hundred sixty-five dollars for the half year from January first, nineteen hundred and twenty-one, to June thirtieth, nineteen hundred and twenty-one; and twenty-four thousand seven hundred thirty dollars for each of the years July first, nineteen hundred and twenty-one, to June thirtieth, nineteen hundred and twenty-two, and from July first, nineteen hundred and twenty-two to June thirtieth, nineteen hundred and twenty-three.

**Emergency clause.** In view of the emergency cited in the preamble, this resolve shall take effect when approved.

## Chapter 160.

Resolve, To Apportion One Hundred and Fifty-one Representatives among the Several Counties, Cities, Towns, Plantations and Classes in the State of Maine.

**Apportionment of representatives to the legislature. Resolved:** That for the eighty-first legislature to and including that of the year nineteen hundred and thirty-one:

**The County of Androscoggin shall choose thirteen representatives** to be apportioned as follows: Auburn, three representatives; Lewiston, five representatives; Lisbon, one representative; East Livermore and

Mechanic Falls, one representative; Livermore, Turner and Minot, one representative; Poland, Greene and Wales, one representative; Webster, Durham and Leeds, one representative.

**The County of Aroostook shall choose sixteen representatives** to be apportioned as follows: Caribou, one representative; Fort Fairfield, one representative; Presque Isle, one representative; Houlton, one representative; Dyer Brook, Oakfield, Moro Plantation, Merrill, Smyrna, New Limerick, Ludlow, Hammond Plantation, Littleton, one representative; Monticello, Bridgewater, Blaine, Mars Hill and E Plantation, one representative; Sherman, Island Falls, Hersey, Crystal, Benedicta, Silver Ridge, Macwahoc, one representative; Linneus, Hodgdon, Cary Plantation, Amity, Glenwood Plantation, Haynesville, Orient, Weston, Bancroft, and Reed Plantation, one representative; Limestone, Caswell Plantation, Connor, Hamlin Plantation, Cyr Plantation, Westmanland Plantation and Stockholm, one representative; Van Buren and Grand Isle, one representative; Ashland, Castle Hill, Masardis, Portage Lake, Oxbow Plantation, Garfield Plantation and Nashville Plantation, one representative; Woodland, Washburn, New Sweden and Perham, one representative; Easton, Chapman, Mapleton, Wade and Westfield, one representative; Frenchville, St. Agatha and Madawaska, one representative; Fort Kent and Wallagrass Plantation, one representative; Eagle Lake, Allagash Plantation, St. Francis Plantation, St. John Plantation, New Canada Plantation, and Winterville Plantation, one representative.

**The County of Cumberland shall choose twenty-four representatives** to be apportioned as follows: Portland, seven representatives; Westbrook, two representatives; South Portland, three representatives; Brunswick, two representatives; Gorham, one representative; Bridgton, one representative; Pownal and Freeport, one representative; Cumberland and Falmouth, one representative; Scarborough and Cape Elizabeth, one representative; Sebago, Baldwin and Standish, one representative; Harrison, Otisfield and Windham, one representative; Gray, Raymond and New Gloucester, one representative; Harpswell, Casco and Naples, one representative; Yarmouth and North Yarmouth, one representative.

**The County of Franklin shall choose four representatives** to be apportioned as follows: Jay and Wilton, one representative; Farmington, Chesterville, New Sharon and Temple, one representative; Carthage, Weld, Avon, Strong, Phillips, Madrid, New Vineyard, Industry, Perkins Plantation and Washington Plantation, one representative; Rangeley, Rangeley Plantation, Sandy River Plantation, Lang Plantation, Dallas Plantation, Coplin Plantation, Eustis, Kingfield, Freeman, Salem, unorganized townships and Redington, one representative.

## CHAP. 160

**The County of Hancock shall choose six representatives** to be apportioned as follows: Deer Isle, Stonington, Sedgwick, Brooklin and Brooksville, one representative; Bucksport, Dedham, Orland, Verona, Penobscot and Castine, one representative; Ellsworth, Surry and Bluehill, one representative; Bar Harbor, Trenton and Hancock, one representative; Mt. Desert, Southwest Harbor, Cranberry Island, Swans Island, Long Island, Tremont, and Lamoine, one representative; Gouldsboro, Plantation Number Thirty-three, Aurora, Amherst, Mariaville, Otis, Plantation Number Twenty-one, Waltham, Eastbrook, Franklin, Sullivan, Sorrento and Winter Harbor, one representative.

**The County of Kennebec shall choose thirteen representatives** to be apportioned as follows: Augusta, two representatives; Waterville, two representatives; Gardiner one representative; Clinton, Albion, Unity Plantation and Benton, one representative; Vassalboro and Winslow, one representative; Chelsea and Farmingdale, one representative; Windsor, Randolph, Pittston and China, one representative; Manchester, Hallowell and West Gardiner, one representative; Monmouth, Winthrop and Litchfield, one representative; Readfield, Mount Vernon, Rome, Wayne, Fayette and Vienna, one representative; Sidney, Belgrade and Oakland, one representative.

**The County of Knox shall choose five representatives** to be apportioned as follows: Rockland, one representative; Thomaston, South Thomaston, Friendship and Cushing, one representative; Rockport, Warren, Union and Washington, one representative; Camden, Hope and Appleton, one representative; Vinalhaven, North Haven, St. George, Matinecus, Isle au Haut, Ctriehaven, Muscle Ridge and Hurricane Isle, one representative.

**The County of Lincoln shall choose three representatives** to be apportioned as follows: Alna, Waldoboro, Whitefield, Jefferson, Somerville and New Castle, one representative; Southport, Boothbay Harbor, Bristol, South Bristol, Boothbay and Monhegan, one representative; Bremen, Damariscotta, Nobleboro, Edgecomb, Dresden, Westport and Wiscasset, one representative.

**The County of Oxford shall choose eight representatives** to be apportioned as follows: Rumford, Hanover and Roxbury, two representatives; Mexico, Peru and Woodstock, one representative; Dixfield, Canton, Hartford, Sumner, Buckfield and Hebron, one representative; Paris and Oxford, one representative; Norway, Waterford, Stoneham, Lovell and Sweden, one representative; Hiram, Porter, Brownfield, Fryeburg, Stow and Denmark, one representative; Bethel, Albany, Greenwood, Gilead, Mason, Grafton, Newry, Upton, Magalloway Plantation, Lincoln Planta-

tion, Milton Plantation, Andover, Byron and all other unclassified territory, one representative.

**The County of Penobscot shall choose seventeen representatives** to be apportioned as follows: Bangor, four representatives; Brewer, one representative; Old Town, one representative; Dexter and Garland, one representative; Newport, Corinna, Exeter and Stetson, one representative; Plymouth, Etna, Levant, Dixmont, Newberg, Kenduskeag and Carmel, one representative; Corinth, Charleston, Hudson, Bradford, La Grange, Argyle, Alton, Edinburg and Howland, one representative; Hampden, Hermon and Glenburn, one representative; Orono and Milford, one representative; Millinocket and East Millinocket, one representative; Orrington, Holden, Eddington, Clifton, Bradley, Greenfield, Veazie and Greebnush, one representative; Burlington, Lowell, Passadumkeag, Enfield and Lincoln, one representative; Lee, Springfield, Carroll, Winn, Webster, Prentiss, Chester, Woodville, Mattamiscontis, Mattawamkeag, Maxfield, Lakeville and Seboeis, one representative; Patten, Mt. **The County of Sagadahoc shall choose five representatives** to be apportioned as follows: Bath, three representatives; Bowdoin, Bowdoinham, Richmond and Georgetown, one representative; Arrowsic, West Bath, Topsham, Woolwich and Phippsburg, one representative.

**The County of Somerset shall choose seven representatives** to be apportioned as follows: Skowhegan, one representative; Fairfield, Smithfield and Mercer, one representative; Palmyra, Detroit, Cornville, and Pittsfield, one representative; Harmony, St. Albans, Ripley, Hartland, Cambridge and Canaan, one representative; Madison, Solon and Athens, one representative; Anson (North), Starks, Norridgewock, Embden and Concord, one representative; Bingham, New Portland, Moscow, Bigelow, Brighton, Caratunk, Dead River, Dennistown, Flagstaff, The Forks, Highland, Jackman, Lexington, Mayfield, Moose River, Pleasant Ridge, West Forks Plantation, and Long Pond Plantation, one representative.

**CHAP. 161**

**The County of Washington shall choose eight representatives** to be apportioned as follows: Calais, one representative; Eastport, one representative; Milbridge, Cherryfield, Beddington, Steuben, Deblois, Harrington, Addison and Columbia, one representative; Columbia Falls, Jonesport, Machiasport, Jonesboro and Cutler, one representative; Machias, Roque Bluffs, Whitneyville, Northfield, Wesley, Centerville, Marshfield, East Machias, Number Eighteen Plantation, and Marion, one representative; Dennysville, Crawford, Number Fourteen Plantation, Perry, Pembroke, Meddybemps, Cooper, Alexander, Robbinston and Charlotte, one representative; Lubec, Trescott, Edmunds and Whiting, one representative; Danforth, Baileyville, Brookton, Topsfield, Princeton, Vanceboro, Baring, Waite, Lambert Lake, I. ## Chapter 161.

Resolve, Authorizing the Payment of Certain Deficiencies.

**Emergency preamble.** Whereas, the various deficiency items comprised in this resolve are long overdue and further delay in the payment thereof will occasion great inconvenience to many departments of the state government and to citizens of the state; and

Whereas, in the opinion of the legislature these facts constitute this resolve an emergency measure, which is immediately necessary for the preservation of the public peace, health or safety, now therefore,
