**CHAP. 161**

**The County of Waldo shall choose four representatives** to be apportioned as follows: Belfast, one representative; Belmont, Liberty, Lincolnville, Searsmont, Morrill, Palermo, Northport, Montville, Freedom, and Knox, one representative; Thorndike, Unity, Burnham, Troy, Brooks, Jackson, Waldo, Monroe and Swanville, one representative; Searsport, Islesboro, Stockton, Prospect, Winterport and Frankfort, one representative.

**The County of Washington shall choose eight representatives** to be apportioned as follows: Calais, one representative; Eastport, one representative; Milbridge, Cherryfield, Beddington, Steuben, Deblois, Harrington, Addison and Columbia, one representative; Columbia Falls, Jonesport, Machiasport, Jonesboro and Cutler, one representative; Machias, Roque Bluffs, Whitneyville, Northfield, Wesley, Centerville, Marshfield, East Machias, Number Eighteen Plantation, and Marion, one representative; Dennysville, Crawford, Number Fourteen Plantation, Perry, Pembroke, Meddybemps, Cooper, Alexander, Robbinston and Charlotte, one representative; Lubec, Trescott, Edmunds and Whiting, one representative; Danforth, Baileyville, Brookton, Topsfield, Princeton, Vanceboro, Baring, Waite, Lambert Lake, I. Township, Forest City, Talmadge, Codyville, Grand Lake Stream, Number Twenty-one Plantation, Kossuth and Number Five Plantation, one representative.

**The County of York shall choose fourteen representatives** to be apportioned as follows: Biddeford, three representatives; Sanford, two representatives; Saco, one representative; Berwick and South Berwick, one representative; Kennebunk and Kennebunkport, one representative; York, Old Orchard and North Kennebunkport, one representative; Lebanon, North Berwick and Wells, one representative; Buxton, Dayton, Hollis and Lyman, one representative; Cornish, Limerick, Limington and Parsonsfield, one representative; Acton, Alfred, Newfield, Shapleigh and Waterboro, one representative; Kittery and Eliot, one representative.

## Chapter 161.

Resolve, Authorizing the Payment of Certain Deficiencies.

**Emergency preamble.** Whereas, the various deficiency items comprised in this resolve are long overdue and further delay in the payment thereof will occasion great inconvenience to many departments of the state government and to citizens of the state; and

Whereas, in the opinion of the legislature these facts constitute this resolve an emergency measure, which is immediately necessary for the preservation of the public peace, health or safety, now therefore,

**Authorizing the payment of certain deficiencies. Resolved:** that the sum of twenty-five thousand six hundred and seventy-two dollars and forty cents (\$25,672.40) be appropriated to pay such deficiencies, as shown by the lists presented by the state auditor to the legislature on January twenty-eight February seventeenth, one thousand nine hundred and twenty-one.

**Emergency clause.** In view of the emergency cited in the preamble this resolve shall take effect when approved.

## Chapter 162.

Resolve, Providing for the Erection and Completion of a State School Building for the State School for Boys at South Portland.

**Emergency preamble.** Whereas, the school facilities at the State School for Boys at South Portland are inadequate to meet present requirements and whereas in the opinion of the legislature this fact constitutes this resolve an emergency measure, which is immediately necessary for the preservation of the public peace, health or safety, now therefore

**School building, State School for Boys. Resolved,** that the sum of ten thousand dollars be appropriated for the erection and completion of a school building at the State School for Boys at South Portland, provided that a like sum be donated to the state for this purpose by the Hon. Arthur R. Gould of Presque Isle, the plans of the school building to be submitted to the governor and council and to the said Arthur R. Gould for their joint approval, the construction and completion of the said building to be under the supervision and control of a committee to be appointed by the governor, consisting of the Hon. Arthur R. Gould as chairman, and two members of the executive council, this appropriation to be available during the period of January first, nineteen hundred and twenty-one to June thirtieth, nineteen hundred and twenty-two.

**Emergency clause.** In view of the emergency cited in the preamble, this resolve shall take effect when approved.

## Chapter 163.

Resolve, in Favor of the Randolph-Gardiner Draw Bridge.

**Emergency preamble.** Whereas, the condition of the bridge across the Kennebec river between the City of Gardiner and the Town of Randolph in this state is such as to constitute a menace to the safety of the travelers
