highway and bridge bonds for the construction of state aid highways, said sum shall be chargeable to any funds available for the maintenance of bridges under laws which shall then be in effect.

Emergency clause. In view of the emergency cited in the preamble, this act shall take effect when approved.

Approved April 9, 1921.

#### Chapter 173.

Resolve, in Favor of the University of Maine.

Emergency preamble. Whereas, the continuance of the courses of instruction in the University of Maine will cease until a date ninety days after the recess of the present session of the legislature unless moneys are appropriated for the expense of the continuance of such courses of instruction, and,

Whereas, the continuance of the courses of instruction at the University of Maine for the ensuing three months is an emergency, and such continuance immediately necessary for the peace, health and safety of the state, now therefore be it

University of Maine, for maintenance and for payment of deficit. Resolved: That there be, and hereby is, appropriated for the maintenance and for payment of indebtedness for the University of Maine the following amounts, namely:

For maintenance from January first, nineteen hundred and twenty-one to June thirtieth, nineteen hundred and twenty-one the sum of one hundred twenty-five thousand dollars; for the period from July first, nineteen hundred and twenty-two, the sum of one hundred ninety-five thousand dollars; for the period from July first, nineteen hundred and twenty-two to June thirtieth, nineteen hundred and twenty-three, the sum of two hundred twenty-five thousand dollars. The sums so appropriated to be divided between the various colleges as shown below, and such amounts are to be used only toward the expenses of each college as indicated; except that the amounts appropriated for the various colleges may be transferred upon the authority of the governor and council. Any unexpended balance may be applied toward the existing deficit.

#### **CHAP. 174**

For payment of indebtedness for the period from July first, nineteen hundred and twenty-one to June thirtieth, nineteen hundred and twenty-two the sum of twenty-two thousand five hundred dollars; for the period from July first, nineteen hundred and twenty-two to June thirtieth, nineteen hundred and twenty-three the sum of twenty-two thousand five hundred dollars.

Emergency clause. In view of the emergency cited in the preamble, this resolve shall take effect when approved.

Passed over the Governor's Veto, April 9, 1921.

#### Chapter 174.

Resolve, Making an Appropriation for the Construction of a New Building at the Northern Maine Sanatorium, Presque Isle, Aroostook County and for the Purchase of Equipment therefor and for Maintenance.

Northern Maine Sanatorium, new building. Resolved: That there be appropriated for the year from July first, nineteen hundred and twenty-one to June thirtieth, nineteen hundred and twenty-two, the sum of sixty-five thousand dollars (\$65,000), to be expended under the direction of the "Board of Trustees for Tuberculosis Sanatoriums" and the governor and council, in constructing and equipping a new building at Northern Maine Sanatorium, Presque Isle.

Unexpended balance continued. Provided that any balance of the sum above appropriated for the year from July first, nineteen hundred and twenty-one to June thirtieth, nineteen hundred and twenty-two which may remain unexpended at the end of the year, shall be available for expenditure during the following year.

Maintenance July 1, 1922-July 30, 1923. Be it further Resolved, that there be appropriated for the Northern Maine Sanatorium for general maintenance, the sum of thirty-five thousand dollars (\$35,000) for the year from July first, nineteen hundred and twenty-two to June thirtieth, nineteen hundred and twenty-three.

Passed over the Governor's Veto, April 9, 1921.

### Chapter 175.

Resolve, Proposing an Amendment to Article Nine of the Constitution to Provide for a Bond Issue for the Purpose of Paying a Bonus to Maine Soldiers and Sailors in the War with Spain.

Proposing constitutional amendment so as to provide for payment of bonus to Spanish war veterans. Resolved: Two-thirds
