## CHAP. 34

upon the wild lands carrying or having in his possession any firearms; or who catches any fish or shoots any wild animal or bird for which there is no close season otherwise provided by law, shall be punished by a fine of not less than ten nor more than one hundred dollars and costs for each offense,' so that said section, as amended, shall read as follows:

'Sec. 39. Penalty provided for catching fish on which there is not otherwise a close season. During the time which shall by such proclamation be made a close season, all provisions of law covering and relating to the close season shall be in force, and a person violating a provision of the same shall be subject to the penalty therein prescribed. Whoever, during the close season fixed by proclamation of the governor, as provided in the preceding section, enters upon the wild lands carrying or having in his possession any firearms; or who catches any fish or shoots any wild animal or bird for which there is no close season otherwise provided by law, shall be punished by a fine of not less than ten nor more than one hundred dollars and costs for each offense.'

### Chapter 34.

An Act to Prohibit the Use of Beam Trawls in the Waters of Sedgwick Harbor, Known as Benjamin's River.

*Be it enacted by the People of the State of Maine, as follows:*

Use of beam trawls in Sedgwick Harbor, prohibited. The use of beam trawls or any similar device is hereby prohibited in Sedgwick Harbor, known as Benjamin's river, under a penalty of not less than five or more than fifty dollars; provided, however, that this act shall not be construed as prohibiting the taking of smelts in the usual manner by the use of purse seines during the time when the use of seines for this purpose is lawful in other waters of the state.

### Chapter 35.

An Act to Establish a Game Sanctuary in the City of Bangor and County of Penobscot.

*Be it enacted by the People of the State of Maine, as follows:*

Game sanctuary established in city of Bangor; limits defined. No person shall, except as herein provided, at any time, hunt, pursue, shoot at or kill any wild animal or any game or wild bird, within the following described territory situated in the city of Bangor in the county of Penobscot: Bounded on the south by the southerly line of said city of Bangor; on the east
