CHAP. 80

Chapter 80.

An Act to Amend Section Nineteen of Chapter Ninety-eight of the Public Laws of Nineteen Hundred and Twenty-one, Relating to Suspension and Revocation of Lobster Licenses.

Be it enacted by the People of the State of Maine, as follows:

P. L., 1921, c. 98, sec. 19; providing for use of lobster licenses by agent of licensee, amended. Section nineteen of chapter ninety-eight of the public laws of nineteen hundred and twenty-one is hereby amended by striking out the words "be employed by another or" and the words "lobster business" in the eleventh line, and inserting after the word "the" in the eleventh line the words 'catching of lobsters,' so that said section, as amended, shall read as follows:

'Sec. 19. In case license is revoked, licensee prohibited from assisting in catching lobsters. If any person, firm, or corporation to whom such license shall be granted shall be incapacitated for any reason, except for the violation of the laws of the state relating to the lobster industry, from using said license, said person, firm or corporation may permit his agent or employee, if a citizen of this state, to perform such duties under the license as may be necessary during the period of his or its incapacity; provided that said agent or employee shall, when performing said duties so licensed, exhibit upon demand of any authorized person, the certificate issued to his superior, as provided in the preceding section. No person whose license has been revoked or suspended shall assist in the catching of lobsters in any way. Every person who shall violate the provisions of this section shall upon conviction be subject to the fines and penalties provided in section seventeen.'

Chapter 81.

An Act to Amend Section Thirty-six of Chapter Two Hundred and Nineteen of the Public Laws of Nineteen Hundred and Seventeen, as Amended by Chapter One Hundred and Ninety-six of the Public Laws of Nineteen Hundred and Nineteen, Relating to the Protection of Caribou.

Be it enacted by the People of the State of Maine, as follows:

P. L., 1917, c. 219, sec. 36; 1919, c. 196; relating to protection of caribou, amended. Section thirty-six of chapter two hundred and nineteen, of the public laws of nineteen hundred and seventeen, as amended by chapter one hundred and ninety-six, of the public laws of nineteen hundred and nineteen, is hereby amended by adding thereto the following paragraph:

'Provided, however, that the commissioner of inland fisheries and game, upon application from any person who has legally killed a caribou beyond
