not more than one thousand dollars, or by imprisonment of not more than one year, or by both such fine and imprisonment.

**Sec. 3.** Act not to take effect until July 1, 1925, as to corporations now existing. Provided, however, that as to corporations now in existence, this act shall not take effect until July first, nineteen hundred and twenty-five.

## Chapter 100.

An Act to Amend Section Twenty-five of Chapter One Hundred and Twenty-four of the Revised Statutes, Relating to Penalty for Falsely Assuming to Be an Officer.

*Be it enacted by the People of the State of Maine, as follows:*

R. S., c. 124, sec. 25; relating to falsely assuming to be an officer, amended. Section twenty-five of chapter one hundred and twenty-four of the revised statutes is hereby amended by striking out the entire section and by inserting in place thereof the following:

'Sec. 25. Law extended so as to apply to health inspectors, health officers, and state highway police; penalty fixed. Whoever falsely assumes to be a justice of the peace, sheriff, deputy sheriff, health inspector or health officer, coroner or constable, inland fish and game warden, commissioner of inland fisheries and game or state highway police and who acts as such or who requires anyone to aid him in a matter pertaining to the duties of such office, shall be punished by imprisonment for not more than one year or by a fine of not more than five hundred dollars, or by both fine and imprisonment.'

## Chapter 101.

An Act to Amend Section Fifty-eight of Chapter Four of the Revised Statutes, Relating to the Purposes for Which Cities and Towns may Raise Money.

*Be it enacted by the People of the State of Maine, as follows:*

R. S., c. 4, sec. 58; relating to certain purposes for which towns may raise money, amended. Section fifty-eight of chapter four of the revised statutes is hereby amended by adding after the words "memorial day" in the fifth line thereof the words 'armistice day, or any other day set apart for patriotic commemoration,' so that said section, as amended, shall read as follows:

'Sec. 58. Towns may raise money to defray expenses of armistice day. Cities and towns may raise money to procure the writing and publication
