CHAP. 35

#### Chapter 35.

An Act Relating to Clerk Hire in the Office of Register of Deeds in the County of Penobscot, to Correct Clerical Error.

Be it enacted by the People of the State of Maine, as follows:

- Sec. 1. Statement of facts. In section forty-five of chapter two hundred and nineteen of the public laws of nineteen hundred and twenty-one, relating to clerk hire in the office of register of deeds for the County of Penobscot, through a clerical error, the compensation for clerks in the office of register of deeds for said County of Penobscot was fixed at two thousand and eighty dollars, when the intention was to fix the compensation at twenty-eight hundred and eighty dollars. The county commissioners of said County of Penobscot have allowed said compensation to be paid up to the first day of January, nineteen hundred and twenty-three, at the rate of twenty-eight hundred and eighty dollars per year.
- Sec. 2. Doings of county commissioners legalized. The aforesaid acts of said county commissioners of said County of Penobscot, in allowing said compensation to be paid at the rate of twenty-eight hundred and eighty dollars per year up to January one, nineteen hundred and twenty-three, are hereby confirmed, legalized and made valid.

#### Chapter 36.

An Act to Amend Chapter One Hundred and Seventy-two of the Private and Special Laws of Eighteen Hundred and Ninety-nine, as Amended by Chapter Two Hundred and Fifty-nine of the Private and Special Laws of Nineteen Hundred and Three, Relating to a Close Time on Lobsters in the Waters of Pigeon Hill Bay.

Be it enacted by the People of the State of Maine, as follows:

P. & S. L., 1899, c. 172; relating to close time on lobsters in Pigeon Hill bay, amended. Chapter one hundred and seventy-two of the private and special laws of eighteen hundred and ninety-nine, as amended, is hereby further amended by striking out all of said section and inserting in place thereof the following:

'Close time more definitely fixed. No person shall set any trap or other device used for catching lobsters between July first and nine A. M. August thirty-first of each year, under a penalty of ten dollars for each trap or other device set within the following described limits: In the waters of Pigeon Hill Bay so-called.'

Approved March 7, 1923.
