CHAP, 17

Chapter 17.

Resolve, to Appropriate Money for Co-operative Agricultural Work Between the College of Agriculture of the University of Maine and the United States Department of Agriculture.

Co-operative agricultural work between U. of M. and U. S. Dep't of Agriculture. Resolved: That there be, and hereby is, appropriated to be paid to the University of Maine for co-operative agricultural work between its college of agriculture and the United States Department of Agriculture, as such work is defined in an act of the Congress of the United States, approved May eighth, nineteen hundred and fourteen, entitled "An Act to provide for co-operative agricultural work between the agricultural colleges in the several states receiving the benefits of an act of Congress, approved July second, eighteen hundred and sixty-two, and acts supplementary thereto, and the United States Department of Agriculture," for the fiscal year to begin July first, nineteen hundred and twenty-three, the sum of forty-eight thousand, three hundred thirty-nine dollars and seventy-four cents, made up of state Smith-Lever regular thirty-seven thousand, three hundred sixty-nine dollars and four cents, and Smith-Lever supplementary ten thousand nine hundred seventy dollars and seventy cents; and for the fiscal year beginning July first, nineteen hundred and twenty-four, the sum of forty-eight thousand, three hundred thirty-nine dollars and seventy-four cents, made up of Smith-Lever regular thirtyseven thousand, three hundred sixty-nine dollars and four cents, and Smith-Lever supplementary ten thousand nine hundred seventy dollars and seventy cents.

Chapter 18.

Resolve, Providing a State Pension for Maria N. Varrell.

Maria N. Varrell, state pension. Resolved: That the sum of six dollars per month be paid to Maria N. Varrell of York, widow of Harmon Varrell, a Civil War veteran, payable quarterly from the fund appropriated for soldiers' pensions, beginning January first, nineteen hundred and twenty-three, and continuing during the pleasure of the legislature. Which payment shall be in lieu of any other state pension now provided by law.

Chapter 19.

Resolve, in Favor of the Maine State Prison for Maintenance and Current Expenses.

Maine State Prison, maintenance and current expenses. Resolved: That there be, and hereby is, appropriated for the Maine state prison for the

fiscal year July first, nineteen hundred and twenty-three, to June thirtieth, nineteen hundred and twenty-four, inclusive, the sum of seventy-three thousand eight hundred dollars for the purposes hereinafter specified, namely:

July 1, 1923—June 30, 1924.

Maintenance, including food supplies, clothing, repairs on	*

And be it further resolved that there be, and hereby is, appropriated for the Maine state prison for the fiscal year July first, nineteen hundred and twenty-four, to June thirtieth, nineteen hundred and twenty-five, inclusive, the further sum of seventy-three thousand eight hundred dollars for the same purpose hereinbefore specified, divided as follows, namely:

Chapter 20.

Resolve, Providing for the Purchase of Reports of the Commemoration of a Century of Peace Between the United States and Canada of the Maine State Bar Association.

Maine State Bar Association, to purchase report. Resolved: That there be, and hereby is, appropriated the sum of five hundred dollars for the purchase from the Maine State Bar Association, copies of the report of the commemoration of a century of peace between the United States and Canada, which are to be printed by the said association, at the same cost per copy as the cost to the association; said volumes to be distributed or exchanged at the discretion of the state librarian.
