CHAP. 73

Chapter 73.

Resolve, in Favor of Samuel Dana, Representative of the Passamaquoddy Tribe of Indians.

• Samuel Dana, representative Passamaquoddy Indians 81st legislature. Resolved: That there be appropriated and paid to Samuel Dana, representative of the Passamaquoddy tribe of Indians at the eighty-first session of the legislature, one hundred and sixty-five dollars for attendance and forty-three dollars for mileage.

Approved March 29, 1923.

Chapter 74.

Resolve, in Favor of James P. Lewis, Representative of the Penobscot Tribe of Indians.

James P. Lewis, representative Penobscot Indians 81st legislature. Resolved: That there be, and hereby is, appropriated to be paid to James P. Lewis, representative of the Penobscot tribe of Indians at the eightyfirst session of the legislature, one hundred sixty-five dollars for attendance and eighteen dollars for mileage.

Chapter 75.

Resolve, Appropriating Money for the Establishment of a Test Laboratory at Caribou in the County of Aroostook.

Test laboratory at Caribou. Resolved: That there be, and hereby is, appropriated the sum of four thousand dollars to be expended by the state department of health under the direction of the governor and council for the purpose of establishing, equipping and maintaining during the years nineteen hundred twenty-three and nineteen hundred twenty-four, of a test laboratory for Aroostook county, same to be located at Caribou.

Approved March 29, 1923.

Chapter 76.

Resolve, in Favor of Northern Maine Sanatorium, at Presque Isle, Aroostook County, for Personal Services, Maintenance, Repairs and Improvements.

Northern Maine Sanatorium. Resolved: That there be, and hereby is, appropriated for the Northern Maine Sanatorium

For personal services, namely, salaries and wages of all officers and employees, except those wholly engaged in repairs, and construction of buildings and equipment, for the period from July first, nineteen hundred twenty-three, to June thirtieth, nineteen hundred twenty-four, the sum of

twenty-two thousand dollars; for the period from July first, nineteen hundred twenty-four, to June thirtieth, nineteen hundred twenty-five, the sum of twenty-two thousand dollars.

For maintenance, namely, all articles of food and all other materials, supplies and expenses incident to maintenance of the institution and for the patients thereof, whether present or absent, for the period from July first, nineteen hundred twenty-three, to June thirtieth, nineteen hundred twenty-four, the sum of forty-six thousand dollars; for the period from July first, nineteen hundred twenty-four, to June thirtieth, nineteen hundred twenty-five, the sum of forty-six thousand dollars.

For repairs and improvements, for the period from July first, nineteen hundred twenty-three, to June thirtieth, nineteen hundred twenty-four, the sum of three thousand dollars; for the period from July first, nineteen hundred twenty-four, to June thirtieth, nineteen hundred twenty-five, the sum of three thousand dollars.

For finishing basement, adding X-ray machine, sterilizer, high pressure boiler, and quarters for the help in the new building, the sum of ten thousand dollars for the year of nineteen hundred and twenty-four.

Chapter 77.

Resolve, in Favor of the Bath Military and Naval Orphan Asylum.

Bath Military and Naval Orphan Asylum. Resolved: That there be paid to the Bath Military and Naval Orphan Asylum for maintenance, fourteen thousand five hundred dollars for the fiscal year from July first, nineteen hundred and twenty-three, to June thirtieth, nineteen hundred and twenty-four; and fourteen thousand five hundred dollars for the fiscal year from July first, nineteen hundred and twenty-four, to June thirtieth, nineteen hundred and twenty-five.

That there be paid for **personal services** in the aforenamed institution, six thousand and five hundred dollars for the fiscal year from July first, nineteen hundred and twenty-three, to June thirtieth, nineteen hundred and twenty-four; and six thousand and five hundred dollars for the fiscal year from July first, nineteen hundred and twenty-four, to June thirtieth, nineteen hundred and twenty-five.

That there be paid for repairs and equipment, two thousand dollars for the fiscal year from July first, nineteen hundred and twenty-three, to June thirtieth, nineteen hundred and twenty-four; and one thousand dollars for
