be, and hereby is, appropriated the sum of one hundred fifty dollars to be expended for the copying of pictures of former speakers of the house of representatives, to be placed in the office of the speaker, pursuant to house order passed by the house of the present session.

Chapter 117.

Resolve, in Favor of Somerset Academy.

Somerset academy, in aid of. Resolved: That there be, and hereby is, appropriated the sum of seven hundred fifty dollars for the fiscal period beginning July first, nineteen hundred twenty-three, and seven hundred fifty dollars for the fiscal period beginning July first, nineteen hundred twenty-four, to be paid to Somerset academy, so-called, in the town of Athens, to be expended under the direction of the board of trustees of said institution.

Chapter 118.

Resolve, on the Payroll of the House of Representatives of the Eighty-first Legislature.
