Schools, public, department of. Salaries and general office expenses and specific appropriations to be deducted from state school fund. R. S. Chap. 16, additional.

Chapter 116.

Chapter 133.

Fish weirs; right to build or extend terminates in one year unless weir is built and maintained. R. S. Chap. 4, sec. 122, amended.

Chapter 134.

European corn borer; declared to be public nuisance. Provision for control and suppression of. New provision. R. S. Chap. 38, additional.

Chapter 135.

Taxes on real estate; where assessed. Purchaser agreeing to pay pro rata share, the tax year is April to April. R. S. Chap. 10, sec. 9, amended.

Hotels and lodging house; licensing of. Register to be kept upon which shall be entered the true name of every person occupying rooms. New provision. R. S. Chap. 31, additional.

Estates, distribution of. Judge of probate may decree payment of funds deposited with county treasurer, to persons entitled thereto. R. S. Chap. 70, sec. 24, amended.

Chapter 144.

Chapter 153.

Superior courts; exchange of justices. Justice to be reimbursed for expenses. May appoint special stenographer. R. S. Chap. 82, sec. 98, amended.

Chapter 155.

Agricultural societies, state aid to. Must have entered and displayed not less than 100 exhibits of vegetables, fruits or dairy products. R. S. Chap. 34, sec. 18, amended.
