CHAP. 50

Chapter 50.

An Act to Change the Salary of the Superintendent of the State School for Boys.
Be it enacted by the People of the State of Maine, as follows:

R. S., c. 117, sec. 29; P. L., 1917, c. 130, sec. 6; relating to salary of superintendent of state school for boys, amended. Section twenty-nine of chapter one hundred and seventeen of the revised statutes, as amended by section six of chapter one hundred and thirty of the public laws of nineteen hundred and seventeen, is hereby amended by striking out the words "fifteen hundred dollars" and inserting in place thereof the words 'eighteen hundred dollars,' so that said section, as amended, shall read as follows:

'Sec. 29. Salary increased. The superintendent of the state school for boys shall receive an annual salary of eighteen hundred dollars.'

Approved March 25, 1925.

Chapter 51.

An Act Relating to the Salary of the Librarian of the Maine State Library.
Be it enacted by the People of the State of Maine, as follows:

P. L., 1921, c. 210, sec. 18; relating to salary of state librarian, amended. Section eighteen of chapter two hundred and ten of the public laws of nineteen hundred and twenty-one is hereby amended by striking out in the second line thereof the words "twenty-eight hundred" and inserting in place thereof the words 'three thousand,' so that said section, as amended, shall read as follows:

'Sec. 18. Salary increased. The librarian shall receive an annual salary of three thousand dollars.'

Chapter 52.

An Act Relating to the Salary of the Clerk of Courts, Knox County.
Be it enacted by the People of the State of Maine, as follows:

R. S., c. 117, sec. 40; P. L., 1921, c. 219; 1923, cc. 21, 105 and 197; relating to compensation of clerks of courts, amended. Section forty of chapter one hundred and seventeen of the revised statutes as amended by chapter two hundred and nineteen of the public laws of nineteen hundred
