writing at the next stated session of the city council, which shall enter the objections at large on its journal and proceed to reconsider the same. If, upon reconsideration, it shall be passed by vote of two-thirds of all the members of the board, it shall have the same force as if approved by the mayor. In case of vacancy in the mayor's office, this section shall not apply to any act of the council. In case the mayor fails to either sign or return the bill at the next session, then it becomes a law as though he had signed it.'

Approved March 9, 1925.

Chapter 18.

An Act Relating to the Bangor Public Library.

Be it enacted by the People of the State of Maine, as follows:

Organization of declared legal; authorized to hold property to amount of \$3,000,000. The trustees of the Bangor public library, a corporation organized under the laws of this state and located at Bangor, county of Penobscot, which organization is hereby declared to be legal and valid, is hereby authorized and empowered for the purposes of its organization to receive, take and hold by deed, devise, bequest or otherwise, property, real, personal and mixed, to the amount of three million dollars (\$3,000,000) including all gifts, conveyances, bequests and devises, heretofore made to said corporation.

Chapter 19.

An Act Relating to Close Time on Lobsters in the Towns of Cutler, Trescott and Lubec, in Washington County.

Be it enacted by the People of the State of Maine, as follows:

P. & S. L., 1915, c. 154; 1923, c. 32; relating to closed time on lobsters in certain waters in towns of Cutler, Trescott and Lubec, amended. Chapter one hundred and fifty-four of the private and special laws of nineteen hundred and fifteen, as amended by chapter thirty-two of the private and special laws of nineteen hundred and twenty-three, is hereby amended by striking out all of said chapter and inserting in place thereof the following:

Closed time July 1, to August 31. 'No person or persons shall set any trap or other device used for catching lobsters between the first day of July and nine A. M. August thirty-first of each year, under a penalty of five dollars for each trap or other device set within the following described

limits: Commencing at Township rock in said town of Cutler, thence running south southwest, two and three-fourths miles; thence south southeast, one-half mile; thence south by west three-fourths west, to the three mile limit; thence running along said three mile limit to a point three miles southeast from West Quoddy Head.'

Approved March 14, 1925.

Chapter 20.

An Act Relating to the Portland Public Library.

Be it enacted by the People of the State of Maine, as follows:

P. & S. L., 1867, c. 174, sec. 2; relating to right of Portland Public Library to hold property, amended. Section two, of chapter one hundred and seventy-four of the private and special laws of eighteen hundred and sixty-seven is hereby amended by striking out the words "five hundred thousand dollars" at the end thereof and substituting therefor the words 'one million dollars,' so that said section, as amended, shall read as follows:

'Sec. 2. Limit increased to \$1,000,000. Said corporation may take and hold real and personal estate and donations, grants, devises or bequests, to the amount of one million dollars.'

Chapter 21.

An Act to Amend Chapter One Hundred and Ten of the Private and Special Laws of Nineteen Hundred and Nine, Relating to the Good Will Home Association.

Be it enacted by the People of the State of Maine, as follows:

P. & S. L., 1897, c. 455, sec. 1; 1909, c. 110; relating to right of Good Will Home Association to hold property, amended. Section one of chapter four hundred and fifty-five of the private and special laws of eighteen hundred and ninety-seven as amended by chapter one hundred and ten of the private and special laws of nineteen hundred and nine is hereby amended by striking out the words "twelve hundred thousand" in the last clause of said section and substituting in the place thereof the words 'five million,' so that said section, as amended, shall read as follows:

'Sec. 1. Limit increased to \$5,000,000. The Good Will Home Association, a charitable corporation formed under the provisions of chapter fifty-five of the revised statutes, for the purpose of aiding needy boys, and located at East Fairfield in Somerset county, is hereby authorized to take
