Chapter 6.

Resolve, in Favor of Animal Husbandry.

Animal husbandry, for scientific investigation in. Resolved: That there be, and hereby is, appropriated the sum of five thousand dollars for the year from July first, nineteen hundred and twenty-five, to June thirthieth, nineteen hundred and twenty-six, and five thousand dollars for the year from July first, nineteen hundred and twenty-six, to June thirtieth, nineteen hundred and twenty-seven, for scientific investigation in animal husbandry. Said sum to be expended under the direction of the Maine Agricultural Experiment Station.

Chapter 7.

Resolve, in Favor of Highmoor Farm, in the Town of Monmouth.

Highmoor farm, maintenance of. Resolved: That there be, and hereby is, appropriated the sum of five thousand dollars for the year from July first, nineteen hundred and twenty-five, to June thirtieth, nineteen hundred and twenty-six, and five thousand dollars for the year from July first, nineteen hundred and twenty-six, to June thirtieth, nineteen hundred and twenty-seven, for the maintenance of Highmoor Farm, in the town of Monmouth. Said sum to be expended under the direction of the Maine Agricultural Experiment Station.

Chapter 8.

Resolve, in Favor of Scientific Investigation in Agriculture in Aroostook County.

Agriculture in Aroostook county, for scientific investigation. Resolved: That there be, and hereby is, appropriated the sum of five thousand dol-

lars for the year from July first, nineteen hundred and twenty-five, to June thirtieth, nineteen hundred and twenty-six, and five thousand dollars for the year from July first, nineteen hundred and twenty-six, to June thirtieth, nineteen hundred and twenty-seven, for scientific investigation in agriculture in Aroostook county. Said sum to be expended under the direction of the Maine Agricultural Experiment Station.

Chapter 9.

Resolve, Memorializing Congress in the Interest of National Defense.

Preamble. Whereas, the president of the United States in a recent message to the congress of the United States has stated that the army and navy of the United States should be strengthened and that a people who neglect their national defense are putting in jeopardy their national honor; and

Whereas, in furtherance of the national defense act of nineteen hundred and twenty and in order to increase and promote the strength and effectiveness of the army, the war department has recommended,

(a) That the regular army be brought back to the strength of one hundred and fifty thousand enlisted men and thirteen thousand officers;

(b) That the national guard be given the support necessary to permit its progressive development toward a strength of two hundred and fifty thousand;

(c) That the organized reserves be fully maintained as contemplated by the National Defense act of nineteen hundred and twenty as the most effective means whereby the citizens of the United States can assure to themselves and to their posterity those blessings to which our national life is dedicated;

(d) That provision be made for a gradual increase in the number accommodated annually in the citizens' military training camps;

Therefore, be it

Memorializing congress indorsing recommendations of war department. Resolved, that the senate and house of representatives of Maine, in legislature assembled indorse the foregoing recommendations; and be it further
