Chapter 63.

Resolve, Providing for a State Pension for Florence J. Judkins, of Lewiston.

Florence J. Judkins, state pension. Resolved: That a pension of twelve dollars per month be, and hereby is, granted to Florence J. Judkins, of Lewiston, to be paid quarterly from the fund appropriated for soldiers' pensions. Said pension shall begin July first, nineteen hundred and twenty-five, and continue until otherwise provided by the legislature.

Approved April 3, 1925.

Chapter 64.

Resolve, Providing for a State Pension for Betsey A. Trask, of Lewiston.

Betsey A. Trask, state pension. Resolved: That a pension of ten dollars per month be, and hereby is, granted to Betsey A. Trask, of Lewiston, to be paid quarterly from the fund appropriated for soldiers' pensions. Said pension shall begin July first, nineteen hundred and twenty-five, and continue until otherwise provided by the legislature.

Chapter 65.

Resolve, Making Available Funds for the State's Share of Reconstruction Under the Bridge Act of the Substructure of the Gardiner and Randolph Bridge.

Emergency preamble. Whereas, the bridge between the city of Gardiner and the town of Randolph in this state is out of repair and its condition such as to constitute a menace to the safety of travelers thereon, and extensive repair thereof is immediately necessary for the preservation of the public peace, health and safety; and

Whereas, the foregoing facts constitute an emergency within the meaning of the constitution of this state; now therefore,

Gardiner-Randolph bridge, in aid of. Resolved: That the sum of thirty-two thousand five hundred dollars, or so much thereof as may be necessary, be and hereby is appropriated as the share of the state under the provisions of the Bridge Act, so-called, for rebuilding the substructure of the bridge between the city of Gardiner and the town of Randolph in the county of Kennebec, the same to be expended under direction of the state highway commission under the provisions of the said Bridge Act. Said sum shall be available for expenditure until June thirtieth, nineteen hundred and twenty-seven. The equivalent of any sum expended by the

state under the provisions of this resolve shall be transferred to the general fund in the treasury from any funds becoming available for the administration of the Bridge Act prior to June thirtieth, nineteen hundred and twenty-six.

Emergency clause. In view of the emergency cited in the preamble, this resolve shall take effect when approved.

Chapter 66.

Resolve, in Favor of the Secretaries of Certain Committees of the Eighty-second Legislature for Expenses of said Committees in Performing Legislative Duties.

Expenses of legislative committees. Resolved: That there be and hereby is appropriated the sum of five hundred and thirty-two dollars and sixteen cents, to be paid to the secretaries of certain committees of the eighty-second legislature for the expenses of said committees in performing legislative duties in accordance with the following schedule:

To Alexander Speirs, secretary of the committee on school for feeble minded, for expenses of said committee in visiting the school, the sum of sixty-two dollars,	\$62.00
To John A. McDonald, secretary of the committee on insane hospitals, for expenses of said committee in visiting the insane hospitals, the sum of sixty-six dollars and thirty cents,	66.30
To E. L. Hight, secretary of the committee on state sanatoriums, for expenses of said committee in visiting state sanatoriums, the sum of three hundred and thirty-seven dollars and sixty-six cents,	337.66
To J. E. Drake, house chairman of the committee on ways and bridges for expenses of said committee in visiting the proposed location of bridge across the Kennebec River, the sum of ten dollars and forty cents,	10.40
To J. Henry Morse, secretary of the committee on state prison, for expenses of said committee visiting state prison, the sum of fifty-five dollars and eighty cents,	55.80

\$532.16

The above amounts to be paid from the appropriation for "Contingent Expenses of Committees," of the eighty-second legislature.
