CHAP. 67

#### Chapter 67.

Resolve, in Favor of Trustees of Juvenile Institutions.

Trustees of juvenile institutions, expenses. Resolved: That there be and hereby is appropriated for the fiscal year July first, nineteen hundred and twenty-five, to June thirtieth, nineteen hundred and twenty-six, inclusive, for the trustees of juvenile institutions the sum of twelve hundred and fifty dollars.

And be it further resolved, that there be and hereby is appropriated for the fiscal year July first, nineteen hundred and twenty-six, to June thirtieth, nineteen hundred and twenty-seven, inclusive, for the trustees of juvenile institutions the sum of twelve hundred and fifty dollars.

#### Chapter 68.

Resolve, in Favor of the State Reformatory for Men for Maintenance, Personal Services, Repairs and Equipment.

State reformatory for men, maintenance and expenses. Resolved: That there be, and hereby is, appropriated, for the state reformatory for men, for the fiscal year from July first nineteen hundred and twenty-five to June thirtieth, nineteen hundred and twenty-six, sixty-six thousand two hundred dollars, of which there shall be applied for maintenance, \$30,000.00

Repairs and equipment, 15,000.00

### Chapter 69.

Resolve, Relating to Apportionment of Representatives among the Several Counties, Cities, Towns, Plantations and Classes in the State of Maine.

Washington county apportionment of representatives. Resolved: That chapter one hundred and sixty of the resolves of nineteen hundred and twenty-one be amended as it relates to the apportionment of representatives for the county of Washington by adding after the words "Kossuth

and Number Five Plantations" the words 'Plantation number ten, range three,' so that said section, as amended, shall read as follows:

'The county of Washington shall choose eight representatives to be apportioned as follows: Calais, one representative; Eastport, one representative; Milbridge, Cherryfield, Beddington, Steuben, Deblois, Harrington, Addison and Columbia, one representative; Columbia Falls, Jonesport, Machiasport, Jonesboro and Cutler, one representative; Machias, Roque Bluffs, Whitneyville, Northfield, Wesley, Centerville, Marshfield, East Machias, Number Eighteen Plantation, and Marion, one representative; Dennysville, Crawford, Number Fourteen Plantation, Perry, Pembroke, Meddybemps, Cooper, Alexander, Robbinston and Charlotte, one representative; Lubec, Trescott, Edmunds and Whiting, one representative; Danforth, Baileyville, Brookton, Topsfield, Princeton, Vanceboro, Baring, Waite, Lambert Lake, I. Township, Forest City, Talmadge, Codyville, Grand Lake Stream, Number Twenty-one Plantation, Kossuth and Number Five Plantation, and Plantation Number Ten, Range Three, one representative.'

#### Chapter 70.

Resolve, in Favor of the Town of Hampden.

Town of Hampden, to reimburse for money deposited with state treasurer. Resolved: That the state highway commission is hereby authorized to pay from the funds now available or hereafter becoming available for the construction of bridges under the provisions of the state and county aid bridge act the sum of nine thousand eight hundred and seventy-five dollars with interest at five per cent from October fourteen, nineteen hundred and twenty-four, to the date of payment to reimburse said town of Hampden for its deposit made with the state treasurer as a means of permitting and expediting the reconstruction of Grist Mill bridge over Souadabscook stream; this amount being the state's portion of the estimated cost of the bridge.

### Chapter 71.

Resolve, Proposing an Amendment to Article IX of the Constitution, Authorizing the Issuing of Bonds to be Used for the Purpose of Building a Bridge Across the Kennebec River Between the City of Bath and the Town of Woolwich.

Proposing constitutional amendment to permit issuing bonds to build bridge across Kennebec river. Resolved: Two-thirds of the legislature
