CHAP. 92

in preparing the weekly cumulative index to senate and house documents, as authorized by the order of the legislature, said sum to be paid out of the appropriation for "Contingent Expenses of the Eighty-second Legislature."

Chapter 92.

Resolve, in Favor of Northern Maine Sanatorium.

Northern Maine sanatorium, maintenance, etc. Resolved: That the sum of two hundred and six thousand, nine hundred and seventy-five dollars be appropriated for the Northern Maine Sanatorium. One hundred and five thousand dollars of said sum to be used during the period commencing July first, nineteen hundred and twenty-five and ending June thirtieth, nineteen hundred and twenty-six, and divided as follows: Thirty-two thousand dollars for personal service, sixty thousand dollars for maintenance, and thirteen thousand dollars for repairs and equipment; and one hundred and one thousand nine hundred and seventy-five dollars of said sum for the period commencing July first, nineteen hundred and twentysix and ending June thirtieth, nineteen hundred and twenty-seven divided as follows: Thirty-two thousand dollars for personal service, sixty thousand dollars for maintenance and nine thousand nine hundred and seventyfive dollars for equipment and repairs.

Chapter 93.

Resolve, in Favor of the Western Maine Sanatorium, for Additional Facilities. Western Maine sanatorium, fire pump. Resolved: That there be, and hereby is, appropriated for the Western Maine Sanatorium, five thousand dollars, to be used for fire pump and hydrants.

Chapter 94.

Resolve, in Favor of the University of Maine ..

University of Maine, maintenance. Resolved: That for the purpose of maintaining the University of Maine, throughout the period of the fiscal year beginning with the first day of July in this present year, there hereby is appropriated the sum of three hundred and forty thousand dollars for maintenance, and sixty thousand dollars for equipment and repairs; and

for the fiscal year dating with the first day of July in nineteen hundred and twenty-six, there is appropriated hereby the sum of three hundred and forty thousand dollars for maintenance, and sixty thousand dollars for equipment and repairs.

Resolve, on the Payroll of the House of Representatives of the Eighty-second Legislature.

Payroll of the house of representatives. Resolved: That there be, and hereby is, appropriated the sum of seventy-two thousand six hundred and fifty-five dollars, to be paid to the persons named in the following payroll according to the sum set against the name of each.
