Chapter 5.

An Act to Prohibit Fishing in Lily Pond, in the Town of Rockport, County of Knox.
Be it enacted by the People of the State of Maine, as follows:

Sec. 1. Fishing in Lily Pond, prohibited. It shall be unlawful for any person at any time to fish for, take, catch or kill any kind of fish in Lily Pond, so-called, in the town of Rockport, county of Knox, for a period of two years from September thirtieth, one thousand nine hundred and twenty-seven. It shall also be unlawful for any person to have in possession at any time any kind of fish taken in violation of any provision of this act.

Sec. 2. Penalties. Whoever violates any provision of this act shall be subject to a penalty of not less than ten dollars, nor more than thirty dollars and costs for each offense, and a further penalty of one dollar for each fish taken, caught, killed or had in possession in violation of any provision of this act.

Sec. 3. Jurisdiction granted to trial justices, police and municipal courts. In all prosecutions arising under this act, trial justices, police and municipal courts, within their counties shall have original and concurrent jurisdiction with the supreme judicial courts and superior courts.

Chapter 6.

An Act Relating to the Unauthorized Use of Insignia of War Veterans.
Be it enacted by the People of the State of Maine, as follows:

R. S., c. 128, sec. 10; P. L., 1921, c. 99; relating to unauthorized use of G. A. R. and Sons of Veterans badges, amended. Section ten of chapter one hundred and twenty-eight of the revised statutes, as amended by

chapter ninety-nine of the public laws of nineteen hundred and twenty-one, is hereby further amended by striking out in the second and eighth lines the words "Sons of Veterans" and inserting in lieu thereof the words 'Sons of Union Veterans of the Civil War,' so that said section, as amended, shall read as follows:

'Sec. 10. Name of Sons of Veterans changed to "Sons of Union Veterans of the Civil War." Whoever wilfully wears the badge, button or other insignia, of the Grand Army of the Republic, of the Sons of Union Veterans of the Civil War, of the United Spanish War Veterans, of the Veterans of Foreign Wars, or of the American Legion, or the official discharge button of the army, navy or marine corps, or of any other military, naval or patriotic organization legally incorporated, or uses or wears the same to obtain aid or assistance thereby within the state, unless he shall be entitled to use or wear the same under the rules and regulations respectively of the Department of Maine of the Grand Army of the Republic, of the Sons of Union Veterans of the Civil War, of the United Spanish War Veterans, of the Veterans of Foreign Wars, or of the American Legion, or under the regulations of the army, navy or marine corps, or of any other military, naval or patriotic organization legally incorporated, shall be punished by imprisonment for not more than thirty days, or by fine not exceeding twenty dollars, or by both such fine and imprisonment.'

Chapter 7.

An Act to Regulate Fishing in the Silver Lakes, So-called, in Manchester, Sidney, and Belgrade, in the County of Kennebec.

Be it enacted by the People of the State of Maine, as follows:

Sec. 1. Ice fishing in certain lakes known as Silver Lakes, prohibited. It shall be unlawful for any person to fish for, take, catch or kill any kind of fish at any time on or through the ice in Tyler Lake, Lily Lake, Spring Lake, Lower Silver Lake, Upper Silver Lake, Fairbanks Lake, Gilman Lake, Bean Lake, Doctors' Lake, Sidney Lake, Carl Lake, Joe's Lake, Chamberlain Lake, Wilman Lake, Penney Lake, or Clark's Lake, said lakes being the chain of lakes known as the Silver Lakes, so-called, situate wholly or partly in the towns of Manchester, Sidney and Belgrade, in the county of Kennebec. It shall also be unlawful for any person to have in possession at any time any kind of fish taken on or through the ice in either of said lakes.
