Chapter 13.

An Act Increasing the Fees for Permits for Opening Paved Public Highways.

Be it enacted by the People of the State of Maine, as follows:

R. S., c. 24, sec. 119; relating to records of permits for excavating in city streets and fees for same, amended. Section one hundred and nineteen of chapter twenty-four of the revised statutes is hereby amended by striking out all of the first sentence in said paragraph after the word "stone" in the sixth line of said paragraph and inserting in place of the part stricken out the following: 'concrete, bitulithic, granite block, brick, wood block, sheet asphalt or other pavements, the following fees: for sheet asphalt, wood block, brick and granite block, all on concrete base, six dollars per square yard; for granite block on gravel base, bitulithic and concrete, three dollars and fifty cents per square yard; for broken stone and all other pavements, two dollars and fifty cents per square yard,' so that said section, as amended, shall read as follows:

'Sec. 119. New classification of pavements; schedule of fees for excavations established. The commissioner of public works or such officer as the city government may appoint, shall keep a record of all permits granted by him, and before any permit is granted (work done by the city employees excepted), the applicant shall pay to the city treasurer for every permit for making an excavation within the driveways of any public highway paved with broken stone, concrete, bitulithic, granite block, brick, wood block, sheet asphalt or other pavements, the following fees: for sheet asphalt, wood block, brick, and granite block, all on concrete base, six dollars per square yard; for granite block on gravel base, bitulithic and concrete, three dollars and fifty cents per square yard; and for broken stone and all other pavements, two dollars and fifty cents per square yard. All such fees paid to the city treasurer shall be regularly accounted for by him in his report to the city council, and shall constitute a special fund for the repaving of said cuts; when such cuts are repaired by the street department, the cost thereof shall be charged to said fund.'

Chapter 14.

An Act to Amend Section Seventy-seven of Chapter Two Hundred and Eleven of the Public Laws of Nineteen Hundred and Twenty-one, Relating to Reserved Automobile Registration Numbers.

Be it enacted by the People of the State of Maine, as follows:

P. L., 1921, c. 211, sec. 77; relating to reserved automobile number

plates, amended. Section seventy-seven of chapter two hundred and eleven of the public laws of nineteen hundred and twenty-one, is hereby amended by striking out the word "three" in the eighth line, and inserting in place thereof the word 'five,' so that said section seventy-seven, as amended, shall read as follows:

'Sec. 77. Pleasure car reserved plates increased from 2000 to 5000. Whenever the owner has once registered a motor vehicle, under the provisions of this act, the secretary shall, at the request of such owner, allow him to keep and use the same number plates for the entire calendar year for which the plates were issued, provided he complies with the other provisions of the motor vehicle law. The secretary shall reserve until December first of each year the same registration number for the succeeding year for persons having registration numbers two to five thousand for pleasure vehicles, and numbers one to five hundred for commercial vehicles, if such person shall, previous to the first day of December of the current year, pay for the registration of his vehicle for the succeeding year and otherwise comply with the provisions of the motor vehicle law.'

Chapter 15.

An Act Relating to Close Time on Scallops.

Be it enacted by the People of the State of Maine, as follows:

R. S., c. 45, sec. 67; P. L., 1917, c. 22; 1923, cc. 83 and 130; relating to close time on scallops and penalties for violation, amended. Section sixty-seven of chapter forty-five of the revised statutes, as amended by chapter twenty-two of the public laws of nineteen hundred seventeen, as amended by chapter eighty-three of the public laws of nineteen hundred twenty-three, and as amended by chapter one hundred and thirty of the public laws of nineteen hundred twenty-three, is hereby further amended by adding in the fourth line thereof the words 'or in the waters of Bagaduce river to a point at the mouth of said river marked by a line and bound, extending from Dice's Head in Castine through the southernmost point of Nautilus Island to the Brooksville shore, between the fifteenth day of April and the first day of January next following of each year,' so that said section, as amended, shall read as follows:

'Sec. 67. Special provision for waters of Bagaduce river. No person shall catch, buy or sell, expose for sale, give away, or have in his possession for any purpose, any scallops, shelled or in the shell, between the fifteenth day of April and the first day of November of each year, or in
