## Chapter 261.

An Act Relating to Clerk Hire in the Office of Register of Deeds, Southern District of Aroostook County.

*Be it enacted by the People of the State of Maine, as follows:*

R. S., c. 117, sec. 45; as amended; relating to clerk hire in county offices, further amended. Section forty-five of chapter one hundred and seventeen of the revised statutes, as amended, is hereby further amended by striking out the words "twenty-four" in the third line of paragraph three of said section, and inserting in place thereof the words 'twenty-nine,' so that said paragraph of said section, in so far as it relates to the amount allowed for clerk hire in the office of register of deeds, Aroostook county, southern district, as amended, shall read as follows:

Allowance for register of deeds, southern district, Aroostook county increased. 'for clerks in the office of register of deeds of the southern district, twenty-nine hundred dollars.'

## Chapter 262.

An Act to Make the Chairman of the Androscoggin County Commissioners a Full Time Office with the Duty of Superintendence of Buildings and to Increase His Salary to Fifteen Hundred Dollars.

*Be it enacted by the People of the State of Maine, as follows:*

R. S., c. 117, sec. 42; as amended; relating to salaries of county commissioners, further amended. Section forty-two of chapter one hundred seventeen of the revised statutes of Maine, as amended, is hereby amended by inserting after the word "dollars" in the fifth line thereof, the words 'except the chairman of said commission who shall devote each full working day to his duties, which shall be hereby increased by adding to them the superintendence of the county buildings and for all his services his salary shall be the sum of fifteen hundred dollars per annum,' so that the amended section in so far as it relates to county commissioners of Androscoggin county shall read beginning at the fifth line thereof:

Androscoggin county chairman, increased to \$1500; to devote full time and act as superintendent of buildings. 'Androscoggin, seven hundred fifty dollars, except the chairman of said commission who shall devote each full working day to his duties, which shall be hereby increased by adding to them the superintendence of the county buildings and for all his services his salary shall be the sum of fifteen hundred dollars per annum.'
